SHIFTING ORDER

COLLEGE, RUN BY SHAMBHU DAYAL TIWARI SHIKSHA PRASAR SAMITI, KHASRA NO. 1537, NEAR NOVODAYA VIDYALAYA, NOWGONG DISTRICT.- CHHATARPUR, MADHYA PRADESH.**


AND WHEREAS, the inspection of the institution was conducted in its new premises on 24-03-2017.

AND WHEREAS, the visiting team report alongwith other documents, videograph was placed before WRC in its **272nd Meeting held on April 06-08, 2017** and the Committee observed that "... This is a case for shifting. The VT visited the institution on 24/03/2017. The CD was seen and VTR perused. The CD shows a building with adequate instructional and infrastructural facilities. The VT has recommended the case.

Hence, Shifting is permitted."


