CLOSURE ORDER

WHEREAS, recognition was granted to the institution, namely, THE BHOPAL SCHOOL OF SOCIAL SCIENCE, HABIBGANJ, BHOPAL-462024, MADHYA PRADESH for conducting B.P.Ed. Course with an annual intake of 50 students vide order dated 23.05.2003.

AND WHEREAS, in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) issued the revised recognition order dated 15.05.2015 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students (one basic unit with two section of 50 (fifty) each) from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

AND WHEREAS, Barkatullah University conducted inspections in B.P.Ed. colleges on the basis of complaints received against the institutions. The University vide letter dated 19.12.2016 has forwarded these inspection reports to WRC, NCTE, Bhopal.

AND WHEREAS, the matter was considered by WRC in its 271st meeting held on March 23-25, 2017 and it was decided that "...The inspection report received from the Barkatullah University, Bhopal was perused. The inspection report reveals the following:-

- (i) The institution has not earmarked the built up area for each of the courses run by it.
- (ii) The land is not in the name of the institution but is licensed by BHEL for 3 years.
- (iii) There are only three teaching staff and they are not approved by the University.

Hence, Show Cause Notice be issued as to why the recognition should not be withdrawn on the above grounds. Reply should be submitted within 30 days." Accordingly, Show Cause Notice was issued on 21.04.2017.

AND WHEREAS, the reply not submitted by the institution and the matter was placed before WRC in its 277th WRC meeting held on June 29-30, 2017 and the Committee decided that "...Show Cause Notice was issued to the institution on 21/04/2017. The institution has not replied to the Show Cause Notice but vide its letter dt. 04/03/2017, the institution has requested for closure of the B.P.Ed. course from the academic session 2016-2017. **Hence, Closure is permitted.FDRs, if any, be returned."**

NOW THEREFORE, Closure is permitted to THE BHOPAL SCHOOL OF SOCIAL SCIENCES, HABIBGANJ, BHOPAL - 462024, MADHYA PRADESH as per clause 3(e) NCTE Regulations, 2014 for conducting B.P.Ed. course.
