WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, THE GRANTHAM COLLEGE OF PHYSICAL EDUCATION, RUN BY THE DROPADI NARAYAN FOUNDATION, DURGA MARG, TALLAIYA, VIDISHA, MADHYA PRADESH for conducting B.P.Ed. course of two years duration with an annual intake of 50 students vide order dated 01.04.2008.

AND WHEREAS, in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) issued the revised recognition order dated 20.05.2015 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students (one basic unit with two section of 50 (fifty) each) from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

AND WHEREAS, Barkatullah University conducted inspections in B.P.Ed. Colleges on the basis of complaints received against the institutions.

AND WHEREAS, the inspection report received from Barkatullah University, Bhopal was placed before WRC in its 267th meeting held on January 23-25, 2017 and the Committee decided that "...The inspection report was perused. The observations are as under :-

- The institution has 4 Acres of shrub land which is less than the NCTE requirement.
- The equipment is insufficient in the Labs.
- There is no provision for indoor games.
- The equipment like dumbbells and Lezims are not available.
- There is no developed athletic track or court in the playground.
- The Principal and teaching staff are not appointed as per NCTE Regulations.
- There is no documentary evidence regarding payment of salary.
- There is only 5 Non-teaching staff.
- There is no attendance Register.

Hence, Show Cause Notice be issued to the institution as to why the Recognition should not be withdrawn on the above grounds. Reply should be submitted within 30 days." Accordingly, Show Cause Notice was issued on 30.01.2017

AND WHEREAS, the reply not submitted by the institution and the matter was placed before WRC in its 277th meeting held on June 29-30, 2017 and the Committee decided that "...Show Cause Notice is issued to the institution on 30/01/2017. The institution has not replied to the Show Cause Notice till date. **Hence, Recognition is withdrawn. FDRs, if any, be returned."**

NOW THEREFORE, the recognition granted to THE GRANTHAM COLLEGE OF PHYSICAL EDUCATION, RUN BY THE DROPADI NARAYAN FOUNDATION, DURGA MARG, TALLAIYA, VIDISHA, MADHYA PRADESH for conducting B.P.Ed. course vide order dated 01.04.2008 is hereby withdrawn under section 17(1) of the NCTE Act, 1993.
