**WITHDRAWAL ORDER**

WHEREAS, WRC, NCTE had granted recognition and/or permission to **SHAMBHAVI COLLEGE OF EDUCATION, 680, MR-4, VIJAYNAGAR, JABALPUR-482002 MADHYA PRADESH** vide order no. APW05341/225073/WRC/5-6/102-II/2008/30742 dt. 17/03/2008 to start the M.Ed. course with an annual intake of 50 seats.

AND WHEREAS, WRO issued a corrigendum, vide No. WRC/APW05341/225073/2008/45099-45103 dated 10.10.2008, regarding, the intake may be read as 25 instead of 50 as mentioned in the recognition order dt. 17.03.2008.

AND WHEREAS, as per M.Ed. norms para 1.(3) of NCTE norms 2009, only institution running B.Ed. programme are eligible to offer M.Ed. course except University Departments which may not be directly running a B.Ed. programme. The recognition of B.Ed. course (APW00631/223173) was refused of said institution vide order No. APW00631/223173/NCTE/WRC/MP/LEGAL/115/2009/53681 dated 11.04.2009.

AND WHEREAS, the matter was placed before WRC in its 192<sup>nd</sup> WRC meeting held on October 30-31, 2013 and it was decided that "...This case should be seen by the RD under the regulatory provisions and take action accordingly."

AND WHEREAS, the letter dated 21.11.2013 was issued to the institution informing that the said institution does not fulfill the provisions as laid down in the Clause 8(5) of NCTE Regulations, 2009, and therefore, the name of the said institution no more figures in the list of recognized institutions of M.Ed. course.

AND WHEREAS, Institution also does not fulfill the para 2 (i) of NCTE norms 2014 of M.Ed. course. The recognition of B.Ed course (APW00631/223173) is refused of said institutions vide order No. APW00631/223173/NCTE/WRC/MP/Legal/115/2009/53681 dt. 11.04.2009.


AND WHEREAS, vide notification dated 28, November, 2014. NCTE notified the new regulation and norms 2014.

AND WHEREAS, As per para 2(i) of NCTE norms, 2014 of M.Ed. course, Institution eligible to apply is as:-

"Institutions offering teacher education programmes for a minimum period of five academic years, being affiliated to a university, and having applied for accreditation from NAAC or any other accrediting agency approved by NCTE."


AND WHEREAS, the matter was placed before WRC in its 278<sup>th</sup> WRC meeting held on July 25-26, 2017 and the Committee decided that "...The recognition for the B.Ed. programme (APW00631/223173) was refused vide order dt. 11.04.2009. Subsequently the institute was informed vide letter dt. 21.11.2013 that it no more figures in the list of recognized institution of the M.Ed. course. **The institute needs to be issued a formal order for withdrawal of recognition.**"

NOW THEREFORE, recognition granted to **SHAMBHAVI COLLEGE OF EDUCATION, 680, MR-4, VIJAYNAGAR, JABALPUR-482002 MADHYA PRADESH** for conducting M.Ed. course vide Recognition order dated 17/03/2008 is hereby withdrawn in terms of section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
