CLOSURE ORDER

WHEREAS, permission was granted to **Kamla Nehru Mahavidyalaya, Campus - Kamla Nehru H.S.S, Kamla Nagar, Kotra Sultanabad, Bhopal - 3, Madhya Pradesh** under section 15 (3) (a) of the NCTE Act, 1993, for conducting M.Ed. course vide order dated 06.07.2007 with an annual intake of 25 students and enhancement of intake was permitted vide order dated 05.03.2011 from 25 to 35 seats.

AND WHEREAS, the WRC issued Revised Recognition Order to **Kamla Nehru Mahavidyalaya, Campus - Kamla Nehru H.S.S, Kamla Nagar, Kotra Sultanabad, Bhopal - 3, Madhya Pradesh** on 18.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (One basic unit) from the academic session 2015-16.

AND WHEREAS, the institution vide letter dated 01.06.2015 has been requested for closure of the M.Ed. programme.

AND WHEREAS, WRC vide letter dt. 10.01.2017 has requested to submit some essential documents.

AND WHEREAS, the institution vide letter dated 27.02.2017 & 03.06.2017 has submitted the documents.

AND WHEREAS, the matter was placed before WRC in its 279th meeting held on August 10-11, 2017 and the Committee decided that "...The society vide letter dt. 01.06.2015 has requested for the closure of the M.Ed. course. It has submitted all the required documents. **Hence, Closure is permitted from the session 2017-2018. FDRs, if any, be returned.**"

NOW, THEREFORE, closure of M.Ed. programme is permitted to **Kamla Nehru Mahavidyalaya, Campus - Kamla Nehru H.S.S, Kamla Nagar, Kotra Sultanabad, Bhopal - 3, Madhya Pradesh** as per clause 3 (e) of NCTE Regulations, 2014 from the session 2017-2018.
