WITHDRAWAL ORDER

Whereas, the WRC had granted the recognition to Naranlal institute of Teacher Education, Run by Shri Mohanlal Harkishandas Kansara, Kelavani Trust near Railway Station, Naranlala compound, Navsari, Gujrat-396445 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/39/2002/05735-39 dt. 20.09.2002.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 Naranlal institute of Teacher Education, Run by Shri Mohanlal Harkishandas Kansara, Kelavani Trust near Railway Station, Naranlala compound, Navsari, Gujrat-396445 offering M.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 13.01.2015 from the institution, a revised recognition order no. WRC/323024/2015/139604 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255th meeting held on June 22-24, 2016 and Committee decided to issue Show Cause Notice dt. 05.08.2016.

And whereas, reply dt. 26.08.2016 was submitted by the institution was placed before the WRC in its 277th meeting held on June 29th - 30th, 2017 and the Committee decided as follows :-

"The case file was seen. In response to the WRC letter dt. 05/08/2016, regarding fulfillment of requirements for 2 units of the B.Ed. course, the institution has represented that it had requested only for 1 unit (50 students). Keeping this in mind the WRC looked at the staff profile and found that the institution had submitted a list of 1 Principal and 6 faculty members. Out of these, the faculty members at serial no. 6 and 7 cannot be considered because their appointments are on contractual basis. Further, there is a shortage of 1 faculty member (requirement is 1+7).

For this existing unit to function, the institution is required to appoint 3 faculty members on regular basis. Of these, 1 should be from Physical Education and another from Performing Arts or Fine Arts. The third can be Methodology/Foundation course. The institution should submit the full list of faculty duly approved by the affiliating body for considering the continuation of Recognition for 1 unit of B.Ed. from the session 2017-2018.

As per NCTE Regulations, 2014, FDRs for 12 lakhs in joint operation with the RD, WRC is required. The institution should also fulfill this condition.

Show Cause Notice be issued on the above grounds and reply should be received within 1 month."

And whereas, the institution was informed vide letter no. WRC/323024/B.Ed./Guj./2017/18716 dt. 05.07.2017.

And whereas, reply dt. 20.07.2017 was submitted by the institution was placed before the WRC in its 282nd meeting held on October 24th – 26th, 2017 and the Committee decided as follows :-

"The case file was seen. Show Cause Notice dated 05.07.2017 was issued to the institution.

The institution vide its reply dated 20.07.2017 has submitted a list of one Principal and 6 staff members duly approved by the Registrar. While lecturer at S.No.8 is not approved. Further, lecturers at S.No.5, 6, 7, 8 are not appointed on regular basis.

The institution has not submitted additional FDR for Rs.4.00 lakhs as was indicated in the Show Cause Notice.

The institution has not complied to the requirements of the Show Cause Notice.

Hence, Recognition is withdrawn from the session 2018-2019."

Now, therefore, the recognition of Naranlal institute of Teacher Education, Run by Shri Mohanlal Harkishandas Kansara, Kelavani Trust near Railway Station, Naranlala compound, Navsari, Gujrat-396445 for conducting B.Ed. programme of two years duration with an annual intake of 50 seats (one basic units of 50 students), is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
