## **WITHDRAWAL ORDER**

Whereas in terms of Section 14 of the NCTE Act, the WRC in its 70<sup>th</sup> meeting decided to grant Recognition to Shri Ambalal M. Patel (Avani Seeds) Mahila Education College, Run by Shri Kanya Kelvani Mandal, Sardar Chowk, Unjha, Mehsana, Gujarat-384170 for conducting B.Ed. course with an annual intake of 100 seats vide order no. WRC/5-6/323129/70<sup>th</sup>/2004/10145 dt. 15.12.2005.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Shri Ambalal M. Patel (Avani Seeds) Mahila Education College, Run by Shri Kanya Kelvani Mandal, Sardar Chowk, Unjha, Mehsana, Gujarat-384170 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014.

And whereas, after the receipt of affidavit dt. 13.01.2015, from the institution, a revised recognition order no. WRC/APW00495/323129/2015/142486 dt 31.05.2015 was issued to the institution for conducting B.Ed. course with an annual intake of 100 seats (two basic units of 50 students each) from session 2015-16.

And whereas, on non-receipt of documents required as per section 3 of Revised Recognition Order dt. 31.05.2015 from the institution, a show cause notice dt. 26.08.2016 under section 17 (1) of the NCTE Act, 1993 was issued to the institution.

And whereas, reply dt. 21.10.2016 submitted by the institution and the matter was placed before WRC in its 278<sup>th</sup> meeting held on July 25- 26, 2017 and the Committee decided as follows:-

*"The case file was seen. In response to the show cause notice dt. 26.08.2016, the institute has submitted the list of one Principal and five faculty members (excluding librarian) out of which four are not qualified.*

*The institute has submitted documentary evidence of fixed deposit of only Rs. 5.00 lakhs with joint operation with RD, WRC.*

*Hence, Recognition is withdrawn from the academic session 2018-2019.*

*FDRs, if any, be returned."*

Now therefore, the recognition granted to Shri Ambalal M. Patel (Avani Seeds) Mahila Education College, Run by Shri Kanya Kelvani Mandal, Sardar Chowk, Unjha, Mehsana, Gujarat-384170 for conducting B.Ed. course with an annual intake of 100 seats is hereby withdrawn from the academic session 2018-2019 in terms of section 17 (1) of NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal (online) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
