**WITHDRAWAL ORDER**

Whereas, the WRC had granted the recognition to Shree Banaskantha Kadva Patidar Sanskar Mandal, Managed By Matrushi Santokba ShankarbhaiGovinda B.Ed. College, Gobari Road, Palanpur, Banaskantha, Gujarat - 385001 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/2-32/61(scm)/323152/2004/4659 dt. 16.07.2004.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 Shree Banaskantha Kadva Patidar Sanskar Mandal, Managed By Matrushi Santokba ShankarbhaiGovinda B.Ed. College, Gobari Road, Palanpur, Banaskantha, Gujarat - 385001 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 08.01.2015 from the institution, a revised recognition order no. WRC/APW00536/323152/2015/142533 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, reply dt. 05.07.2017 was submitted by the institution was placed before the WRC in its 278<sup>th</sup> meeting held on July 25<sup>th</sup> - 26<sup>th</sup>, 2017 and the Committee decided as follows :-

"The case file was seen. In response to the revised recognition order dt. 31.05.2015, the institute has submitted two lists of faculty members, one consisting of a Principal and three faculty members appointed before NCTE Regulations, 2014, poor qualified and approved. In the second list of faculty members appointed in 2015 faculty members at sr. no. 3, 4, 5, 6, 7 & 9 are not qualified as per NCTE Regulations, 2014.

The institute has also not submitted a B.C.C. counter signed by a Govt. Engineer.

The institute should submit a list of one Principal and 15 qualified faculty members approved by the competent authority and the B.C.C. from a Govt. Engineer.

**Show Cause Notice be issued on the above grounds. Reply should be received within 1 month."**

And whereas, the institution was informed vide letter no. WRC/APW00536/323152/278<sup>th</sup>/B.Ed./Guj./2017/187947 dt. 01.08.2017.

And whereas, reply dt. 22.08.2017 was submitted by the institution was placed before the WRC in its 282<sup>nd</sup> meeting held on October 24<sup>th</sup> - 26<sup>th</sup>, 2017 and the Committee decided as follows :-

"The case file was seen. Compliance was sought from the institution vide letter dated 01.08.2017 regarding the appointment of staff and Building Completion Certificate.

The institution has not complied with the requirements till date.

**Hence, Recognition is withdrawn from the session 2018-2019."**

Now, therefore, the recognition of Shree Banaskantha Kadva Patidar Sanskar Mandal, Managed By Matrushi Santokba ShankarbhaiGovinda B.Ed. College, Gobari Road, Palanpur, Banaskantha, Gujarat - 385001 for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
