**WITHDRAWAL ORDER**

Whereas in terms of Section 14 of the NCTE Act, the WRC in its 76<sup>th</sup> meeting decided to grant Recognition to Shri Lokniketan Shikshan Mahavidyalaya, AT. PO. Lokniketan Ratanpur, Tal. Palanpur, Banaskantha, Gujarat-385002 for conducting B.Ed. course with an annual intake of 100 seats vide order no. WRC/2-32/76<sup>th</sup>/323223/2005/6353 dt. 09.08.2005.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Shri Lokniketan Shikshan Mahavidyalaya, AT. PO. Lokniketan Ratanpur, Tal. Palanpur, Banaskantha, Gujarat-385002 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014.

And whereas, after the receipt of affidavit dt. 22.01.2015, from the institution, a revised recognition order no. WRC/APW01501/323223/2015/145208 dt 31.05.2015 was issued to the institution for conducting B.Ed. course with an annual intake of 100 seats (two basic units of 50 students each) from the academic session 2015-16.

And whereas, on non-receipt of documents required as per section 3 of Revised Recognition Order dt. 31.05.2015 from the institution, a show cause notice under section 17 (1) of the NCTE Act, 1993 dt. 24.08.2016 was issued to the institution.

And whereas, reply dt. 28.09.2016 submitted by the institution was placed before WRC in its 276<sup>th</sup> meeting held on May 30-31, 2017 and the Committee decided as follows:-

*"The case file was seen. In response to the Show Cause Notice issued on 24/08/2016, the institution vide letter dt. 28/09/2016 has submitted various documents.*

*However, the following deficiencies are seen:-*

- i) The list of 5 faculty members (excluding Librarian) submitted by the institution is not approved by the affiliating body.*
- ii) FDRs in joint name have not been submitted.*
- iii) The latest Building Completion Certificate approved by the competent authority (RES/Govt Engineer) has not been submitted.*

*Compliance in this matter should be submitted within 1 month failing which action will be taken under section 17 of the NCTE Act, 1993."*

And whereas, accordingly decision of WRC was conveyed to the institution vide letter dt. 05.06.2017.

And whereas, the institution has not submitted any reply and matter was placed before WRC in its 278<sup>th</sup> meeting held on July 25<sup>th</sup> - 26<sup>th</sup>, 2017 and the Committee decided as follows:-

*"The case file was seen. Show cause notice was issued to the institution on 05.06.2017:*

*The institute has not replied till date. Recognition is withdrawn from the session 2018-2019.*

*FDRs, if any, be returned."*

Now therefore, the recognition granted to Shri Lokniketan Shikshan Mahavidyalaya, AT. PO. Lokniketan Ratanpur, Tal. Palanpur, Banaskantha, Gujarat-385002 for conducting B.Ed. course with an annual intake of 100 seats is hereby withdrawn from the academic session 2018-2019 in terms of section 17 (1) of NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal (online) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
