WITHDRAWAL ORDER

Date: 1. Aug.

Whereas in terms of Section 14 of the NCTE Act, the WRC in its 98th meeting decided to grant Recognition to Shri Maharshi Dayanand Saraswati B.Ed. College, Tankara, Rajkot, Gujarat - 363650 for conducting B.Ed. course with an annual intake of 100 seats (two basic unit of 50 students each) vide order no. WRC/5-6/98th/2007/c-18189 dt. 26.06.2007.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Shri Maharshi Dayanand Saraswati B.Ed. College, Tankara, Rajkot, Gujarat - 363650 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014.

And whereas, after the receipt of affidavit dt. 22.01.2015, from the institution, a revised recognition order no. WRC/APW04034/323395/2015/148090-8097 dt 31.05.2015 was issued to the institution for conducting B.Ed. course with an annual intake of 100 seats (two basic units of 50 students each) from session 2015-16.

And whereas, on non-receipt of documents required as per section 3 of Revised Recognition Order dt. 31.05.2015 from the institution, a show cause notice under section 17 (1) of the NCTE Act, 1993 dt. 09.08.2016 was issued to the institution.

And whereas, reply dt. 22.08.2016 submitted by the institution and the matter was placed before WRC in its 278th meeting held on July 25th - 26th, 2017 and the Committee decided as follows:-

"The case file was seen. In response to the show cause notice dt. 09.08.2016, the institute has not submitted FDRs for 12 lakhs in joint operation with the RD, WRC, Building completion certificate counter signed by the Govt. Engineer and staff profile of one Principal and 7 staff members approved by the competent authority.

Hence, Recognition is withdrawn from the academic session 2018-2019.

FDRs, if any, be returned."

Now therefore, the recognition granted to Shri Maharshi Dayanand Saraswati B.Ed. College, Tankara, Rajkot, Gujarat for conducting B.Ed. course with an annual intake of 100 seats is hereby withdrawn from the academic session 2018-2019 in terms of section 17 (1) of NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal (online) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
