Permission for Shifting of Premises

Whereas, recognition was granted to the institution, Sardar Patel College of Education, Vidyanagar-Vadtal Road, Bakrol, District- Anand, Gujarat- 388315 for B.Ed course with an annual intake of 100 students vide order no. WRC/5-6/101/2008/C-28196-28202 dated 19.05.2008.

And whereas, a revised recognition order no. WRC/APW04609/323446/2015/143264 dt. 31.05.2015 was issued for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

And whereas, the Institution vide letter no. TFT/corrs/750/15 dt. 24.10.2015 submitted an application for shifting of premises from Vidyanagar-Vadtal Road, Bakrol, Anand, Gujarat- 388315 to Sardar Patel Education Campus, S.No. 981, Vidyanagar-Vadtal Road, Bakrol, Anand, Gujarat - 388315.

And whereas, the matter was placed before WRC in its 235th meeting held on November 23rd-24th, 2015. The Committee decided to issue Show Cause Notice dt. 02.12.2015.

And whereas, reply of Show Cause Notice was received in the office on 17.12.2015 & the case was placed in 256th meeting held on 19th - 21th July, 2016 and committee was decided to issue Show Cause Notice dt. 25.07.2016.

And whereas, reply of Show Cause Notice was received in the office on 01.08.2016 & the case was placed in 267th meeting held on 23rd - 25th January, 2017 and committee was decided to constitute VT.

And whereas, the inspection of the institution was conducted on 02.03.2017 & 03.03.2017.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 271st meeting of WRC held on March, 23rd-25th, 2017 and committee decided as follows :-

"The case file was seen. This is a case of shifting. VT visited the institution on 02-03.03.2017. VTR was perused and the CD was viewed. CD shows a good building with adequate infrastructural and instructional facilities. VT has recommended the case.

Hence, Shifting is permitted."
