**WITHDRAWAL ORDER**

Whereas, the WRC had granted the recognition to Bharad Institute of Teachers Education, Shree Mohan Education & Charitable Trust, Plot No. 233, Bhavnagar State highway, Kasturbadham (Tramba), Rajkot, Gujarat - 360020 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/105/2008/39278-39283 dt. 20.08.2008.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Bharad Institute of Teachers Education, Shree Mohan Education & Charitable Trust, Plot No. 233, Bhavnagar State highway, Kasturbadham (Tramba), Rajkot, Gujarat - 360020 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 02.03.2015 from the institution, a revised recognition order no. WRC/APW04731/323455/2015/148745 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 50 seats (one basic units of 50 students) from session 2015-16.

And whereas, the WRC vide revised recognition order dt. 31.05.2015 had directed the institution to submit the followings documents in compliance of the NCTE Regulations, 2014 :-

1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the matter was placed before the WRC in its 255<sup>th</sup> meeting held on June 22-24, 2016 and Committee decided to issue Show Cause Notice dt. 29.08.2016.

And whereas, reply dt. 14.09.2016 was submitted by the institution was placed before the WRC in its 282<sup>nd</sup> meeting held on October 24<sup>th</sup> - 26<sup>th</sup>, 2017 and the Committee decided as follows :-

"The case file was seen. Show Cause Notice dated 29.08.2016 was issued to the institution.

The institution vide its reply dated 14.09.2016 has submitted a list of 9 staff members duly approved by the Registrar. However, the Principal has not been appointed.

The Building Completion Certificate is not countersigned by the Govt. Engineer.

FDRs for Rs.12.00 lakhs in joint operation with Regional Director are not submitted.

The institution has not complied to the requirements of the Show Cause Notice.

**Hence, Recognition is withdrawn from the session 2018-2019."**

Now, therefore, the recognition of Bharad Institute of Teachers Education, Shree Mohan Education & Charitable Trust, Plot No. 233, Bhavnagar State highway, Kasturbadham (Tramba), Rajkot, Gujarat - 360020 for conducting B.Ed. programme of two years duration with an annual intake of 50 seats (one basic units of 50 students), is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
