Permission for Shifting of Premises

Whereas, recognition was granted to the institution, Shri S.R. Patel B.Ed. College, Vidhyadeep Charitable Trust, Shantikunj Education Complex, Shantikunj Co. Opp. Housing Society LTD., Palanpur, Jakatnaka, Surat, Gujarat - 395010 for B.Ed course with an annual intake of 100 students vide order no. WRC/5-6/101/2008/C-28196-28202 dated 31.01.2008.

And whereas, a revised recognition order no. WRC/APW05467/323521/2015/140602 dt. 31.05.2015 was issued for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

And whereas, the institution vide letter no. VCT/B.Ed./2015 dt. 28.10.2015 submitted an application for shifting of premises from Shantikunj Education Complex, Shantikunj Coop. And whereas, the matter was placed before WRC in its 264<sup>th</sup> meeting held on December 14<sup>th</sup>-15<sup>th</sup>, 2016. The Committee decided to constitute visiting team.

And whereas, the inspection of the institution was conducted on 03.02.2017.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 271<sup>st</sup> meeting of WRC held on March, 23<sup>rd</sup>-25<sup>th</sup>, 2017 and committee decided as follows :-

*"The case file was seen. This is a case of shifting. VT visited the institution on 03.02.2017. VTR was perused and the CD was viewed. CD shows a good building with adequate infrastructural and instructional facilities. VT has recommended the case.*

**Hence, Shifting is permitted."**

Now therefore, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, **permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted for change of premises of Shri S.R.
