WITHDRAWAL ORDER

Date: **31-7-17**

Whereas in terms of Section 14 of the NCTE Act, 1993, Department of Education, Hemchandracharya North Gujarat university, University Road, Post Box No.-21, Dist-Patan, Gujarat-384265 had submitted the application on 29.12.2005 to the Western Regional Committee of the NCTE for grant of recognition of additional intake for M.Ed. course.

And whereas, the WRC had granted the recognition to Department of Education, Hemchandracharya North Gujarat university, University Road, Post Box No.-21, Dist-Patan, Gujarat-384265 for M.Ed. course with an annual additional intake of 25 students the total approved intake for the M.Ed. (R.E.) course becomes 50(PG) vide order No. WRC/APW03337/325015 (Addl)/2008/40697-40702 dt. 29.08.2008.

And whereas, complaint was received in this office from NCTE, Hqrs. New Delhi that the North Gujarat University, Patan, Gujarat is running the M.Ed. programme with an intake of two units without providing required faculty, Action under Section 17 may be initiated in this regard.

And whereas, complaint was placed before the WRC in its 121st Meeting held on July 8-9, 2009 and the committee decided as follows:-

"Affidavits of individual staff members for both the units of M.Ed. be submitted within 21 days of the receipt of NCTE letter failing which recognition will be withdrawn with immediate effect".

Accordingly letter was issued to the institution on dt. 19.08.2009 and reply of was submitted by the institution on dt. 30.09.2009.

And whereas, the matter was placed before the WRC in its 127th meeting held on October 14-15, 2009 and Committee decided to issue Show Cause Notice on following points:-

"The university was given recognition to run two units of M.Ed. However, it is having staff to run one unit only.

Hence, show cause notice be issued for withdrawal of recognition of one unit under Section 17(1) of NCTE Act 1993."

Accordingly Show Cause Notice letter was issued to the institution on dt. 24.10.2009 and reply of WRC letter was submitted by the institution on dt. 07.12.2009.

And whereas, the matter was placed before the WRC in its 129th meeting held on December 22-23, 2009 and Committee decided as follows:-

"The institution be asked to complete the selection process and submit the list of the staff for the two units of the M.Ed. course, separately within 45 days of the issue of this letter. The WRC will take appropriate decision on receipt of the reply."

Accordingly letter was issued to the institution on dt. 09.01.2009 and reply of WRC letter was not submitted by the institution.

And whereas, institution was submitted an affidavit dt. 12.01.2015 for compliance of NCTE Regulations, 2014 and also submitted a letter dt. 08.12.2016 received in this office on 14.12.2016 for submission of NAAC certificate dt. 19.02. 2016.

Accordingly WRO letter was issued to the institution on dt. 03.02.2017 for submission of approved staff list. And reply of WRO letter was submitted by the institution on dt. 06.03.2017.

And whereas, the matter was placed before the WRC in its 272nd meeting held on April 6-8, 2017 and Committee decided issue Show Cause Notice on following points:-

"The case file was seen. In response to the LOI, the institution has submitted a list of 1 Professor and 4 Assistant Professors.

As per Appendix-5 of the Regulations, the requirement of faculty is 2 Professors, 2 Associate Professors and 6 Assistant Professors.

Hence, Show Cause Notice be issued as to why the Recognition should not be withdrawn on the above grounds.

The Applicant be informed that only if the formalities necessary after issue of LOI are completed well before 02.05.2017, can the case be considered for the session 2017-2018."

Accordingly Show Cause Notice letter was issued to the institution on dt. 21.04.2017 and reply was submitted by the institution on dt. 08.05.2017.

And whereas, the matter was placed before the WRC in its 276th meeting held on May 30-31, 2017 and Committee decided as follows:-

"The case file was seen. Show Cause Notice was issued to the institution on 08/05/2017. The reply of the institution is not satisfactory and has not taken into consideration the NCTE Regulations, Appendix-5. There is no provision for appointment of staff on teacher-student ratio. Whether the number of students admitted is 10 or 50, staff should be appointed as per Appendix-5, NCTE Regulations, 2014.

Hence, Recognition granted for additional unit of M.Ed. course is withdrawn from the academic session 2017-2018.

Further, the institution should submit the list of students admitted in the M.Ed. program for the session 2017-2018."

Now, therefore, the recognition granted to Department of Education Hemchandracharya North Gujarat University, University Road, Post Box No.-21, Dist-Patan, Gujarat-384265, for additional unit (50 students) of the M.ED course is hereby withdrawn from the academic session 2017-2018 in terms of Section 17(1) of the NCTE Act, 1993.

Now, therefore, Further, the institution should submit the list of students admitted in the M.Ed. programme for the session 2017-2018.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
