ORDER for Shifting of Premises

Whereas, recognition was granted to the institution, Shri Shankracharya Mahavidyalaya, (Run by Shri Gangajali Education Society), Laxmi Narayan Temple, Sector-VI, Bhilai, Chhattisgarh for M.Ed course with an annual intake of 40 students, vide order no. F.No.WRC/APW03948/5-6/103rd/2008/25196-35201, dated 28.05.2008.

And whereas, a revised recognition order no. WRC/APW03948/725008/2015/136194 dt. 20.05.2015 was issued for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one basic unit of 50 students).

And whereas, the Institution vide letter dt. 28.10.2015 submitted an application on 30.10.2015 for shifting of premises from Shri Shankracharya Mahavidyalaya, Run by Shri Gangajali Education Society, Laxmi Narayan Temple, Sector- VI, Bhilai, Chhattisgarh to Shri Shankracharya Mahavidyalaya , Khasra No. - 97/2, Near Shri Shankaracharya Technical Campus, Beside Petrol Pump, Juniwani, Bhilai Nagar, Distt. - Durg, Chhattisgarh - 490020.

And whereas, the matter was placed before WRC in its 234th meeting held on November 03-05, 2015. The Committee decided to constitute visiting team.

And whereas, the inspection of the institution was conducted on 30.12.2015.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 242nd meeting of WRC held on February, 11-13, 2016 and committee decided to issue show cause notice.

And whereas, the show cause notice letter was issued to the institution on 18.02.2016, and reply of show cause notice was submitted by the institution on dt. 31.03.2016.

And whereas, the reply of show cause notice was placed in 253rd meeting of WRC held on 24th - 26th May, 2016 and committee decided to issue clarification.

And whereas, the clarification letter was issued to the institution on 10.06.2016, and reply of clarification was submitted by the institution on dt. 02.06.2016 and 23.08.2016.

And whereas, the reply of clarification was placed in 261st meeting of WRC held on 26th - 28th October, 2016 and committee decided to as follows:-

"The case file was seen. In response to the Clarification letter issued on 10/06/2016, the institution vide letter dt. 23/08/2016 has submitted originally certified copy of land documents.

Hence, Shifting is permitted."

Now therefore, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, **permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted for change of premises of Shri Shankracharya Mahavidyalaya** (Run by Shri Gangajali Education Society), from Laxmi Narayan Temple, Sector- VI, Bhilai, Chhattisgarh **to Khasra No. - 97/2, Near Shri Shankaracharya Technical Campus, Beside Petrol Pump, Juniwani, Bhilai Nagar, Distt. - Durg, Chhattisgarh - 490020** with immediate effect for conducting B.Ed. course of two years duration with an annual intake of 200 students (two basic units of 50 students each & Additional two units of 50 students each). The institution has move towards a composite institution gradually, as per provision of NCTE Regulations, 2014.
