**WITHDRAWAL ORDER**

WHEREAS, recognition was granted to the institution namely, PITAMBRA PITH SHIKSHA PRASARNI INSTITUTE, PLOT/KHASARA NO.537/1/1, PLOT NUMBER : PHN 50/13, STREET NUMBER : 273 VILLAGE : JASGUWAN, POST OFFICE : BIJAWAR TEHSIL/TALUKA : BIJAWAR, TOWN/CITY : BIJAWAR, DISTRICT : CHHATARPUR, PIN CODE : 471405, MADHYA PRADESH under section 14(3)(a) of NCTE Act, 1993 for conducting D.El.Ed. course of two years duration with an annual intake of 50 students vide order dated 01.08.2012

AND WHEREAS, Rajya Shiksha Kendra vide letter dated 11.08.2017 has forwarded the report from the Collector, Chhatarpur regarding complaints about the institution. The Rajya Shiksha Kendra has recommended that the recognition be withdrawn for the D.El.Ed. course

AND WHEREAS, the matter was placed before WRC in its 280<sup>th</sup> meeting held on August 31-September 1, 2017 and the Committee decided that "...Rajya Shiksha Kendra, Bhopal vide letter dt. 11.08.2017 forwarded the report from Collector, Chhatarpur regarding complaints about the institution. The Rajya Shiksha Kendra has recommended that the recognition be withdrawn for the D.El.Ed. course. Show Cause Notice be issued as to why the recognition of the course should not be withdrawn. Reply should be received within 21 days. Accordingly, Show Cause Notice was issued on 07.09.2017.

AND WHEREAS, the reply received from the institution was placed before WRC in its 285<sup>th</sup> meeting held on December 19-21, 2017 and the Committee decided that "...Show Cause Notice was issued in this case on 07.09.2017. Reply received from the institution on 25.09.2017. There has not been any substantive reply from the institution. **Therefore, Recognition is withdrawn from the academic session 2018-2019.**"

NOW THEREFORE, the recognition granted to PITAMBRA PITH SHIKSHA PRASARNI INSTITUTE, PLOT/KHASARA NO.537/1/1, PLOT NUMBER : PHN 50/13, STREET NUMBER : 273 VILLAGE : JASGUWAN, POST OFFICE : BIJAWAR TEHSIL/TALUKA : BIJAWAR, TOWN/CITY : BIJAWAR, DISTRICT : CHHATARPUR, PIN CODE : 471405, MADHYA PRADESH for conducting D.El.Ed. course vide order dated 01.08.2012 is hereby withdrawn under section 17(1) of the NCTE Act, 1993 from the academic session 2018-2019.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
