WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to OJASWINI GIRLS COLLEGE, PLOT NO. 4/1, 4/4, SAGAR ROAD, VILLAGE - HATHNA, P.O. /TEHSIL / DIST. DAMOH - 470661, MADHYA PRADESH for D.El.Ed. course vide order dated 31.05.2015 for an annual intake of 50 students.

AND WHEREAS, the institution applied for change of name of D.El.Ed course from OJASWINI GIRLS COLLEGE to OJASWINI COLLEGE OF EDUCATION.
