Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, Shantri Bai Art, Commerce and Science College, Plot No. 2041/8/2, Post - Mahasamund, District - Mahasamund, Chhattisgarh - 493445 had submitted the application on 28.09.2011 to the Western Regional Committee of the NCTE for grant of recognition to Shantri Bai Art, Commerce and Science College, Plot No. 2041/8/2, Post - Mahasamund, District - Mahasamund, Chhattisgarh - 493445 for conducting D.El.Ed. Course with an intake of 50 seats.

And whereas, the proposal was examined by WRC in its 194th meeting held on 26th - 27th November, 2013 and the committee decided to the recognition was refused u/s 14 (3) (b) of NCTE Regulations, 2009 on the following points:-

The case file was seen very carefully. LOI was issued to the institution on 30.11.2012. Then a Show Cause Notice was issued dated 11.03.2013, to which no reply has been submitted by the institution.

Hence, Recognition is refused u/s 14(3)(b) of NCTE Act, 1993.

And whereas, Refusal order was issued to the institution on dt. 03.12.2013.

And whereas, Institution had approach the appeal u/s 18 of the NCTE Act, 1993 to NCTE, Hqrs. New Delhi, in compliance of order dt. 03.12.2013 and the Appeal Committee passed by the order dt. 29.05.2014 and decided that:-

The Council hereby remands back the case of Shantri Bai Arts Commerce and Science College, Mahasamund, Chhattisgarh to the WRC, NCTE, for necessary action as indicated above.

And whereas, the institution had submitted the reply dt. 18.06.2014 received in this office on dt. 23.06.2014 and matter was placed before the WRC in its 211th Meeting of WRC held on 31st October, 2014 and Committee decided to "Secondly, the case can be processed further after the new Regulations are notified, in view of the Hon'ble Supreme Court order dated 10.09.2013, 07.03.2014 & 24.03.2014."

And whereas, the institution has submitted the reply on dt. 22.12.2014 and 14.01.2015 and matter was placed before the WRC in its 225th meeting of WRC held on 14-15 May, 2015 and Committee decided to issue Show Cause Notice on following points:-

The case file was seen. LOI dated 30.11.2012 was issued. Since the formalities required after issue of LOI were not completed by the applicant even after Show Cause Notice etc. Recognition was refused by WRC vide order dated 03.12.2013. The applicant approached the Appellate Authority which remanded the case to WRC to consider the reply of the institution dated 11.04.2013. The case was then seen in the 211th meeting (31st October, 2014) and a letter to obtain clarification dated 24.11.2014. WRO also sent a letter dated 23.12.2014 for submission of the Affidavit consenting to function under NCTE Regulations, 2014. Till date the Affidavit consenting to function under NCTE Regulations, 2014 has not been received.

Further, the staff list is not in original. Photocopy of staff list cannot be accepted.

It is also seen that the case of this applicant for B.Ed. course is also being simultaneously processed in the WRO. Identical land documents have been submitted in this case (APW02105/ 723077). On the basis of the norms specified in Appendix-2 of NCTE Regulations, 2014 (for D.El.Ed.) and Appendix-4 of NCTE Regulations, 2014 (for B.Ed.), the land area and the built up area are both less.

FDR for Rs.4.00 lakhs has also not been submitted.

Hence, Show Cause Notice be issued on the above grounds.

Accordingly, Show Cause Notice letter was issued to the institution on 22.05.2015.

And whereas, institution has not submitted the reply of show cause notice letter dt. 22.05.2015 to till date and matter was placed before the WRC in its 263rd meeting of WRC held on November 25-27, 2016 and Committee decided to issue refusal order to the institution on following points:-:-

The case file was seen. Show Cause Notice was issued to the institution on 22/05/2015 regarding various deficiencies. The institution has not replied till date.

Hence, Recognition is refused.

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to , D.El.Ed. Course to Shantri Bai Art, Commerce and Science College, Plot No. 2041/8/2, Post - Mahasamund, District - Mahasamund, Chhattisgarh - 493445.

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order. The guidelines of appeal may be downloaded from the NCTE website.
