WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to BHARAT COLLEGE OF EDUCATION, PLOT NUMBER : 68/1, VILLAGE : KALA PAHAD, POST OFFICE : DATIA, TEHSIL/TALUKA : DATIA, TOWN/CITY : DATIA, DISTRICT : DATIA 475661, MADHYA PRADESH for D.El.Ed. course vide order dated 26.02.2014 for an annual intake of 50 students.

AND WHEREAS, the institution applied for change of name from BHARAT COLLEGE OF EDUCATION to BHARAT COLLEGE.
