ORDER

Whereas, in terms of section 15 of the NCTE Act, Ayush College of Education Meduka, Plot/Khasra Number: 1018/1, 1017/2gaa, 1017/2gha, Village: Meduka, Post: Darri, Tehsil/City: Pendra Road, District: Bilaspur: 495117, Chhattisgarh. had submitted the application on 28.12.2012 to the Western Regional Committee, of the NCTE, for grant of recognition/permission for starting the D.E.C.Ed. course of 02 years duration.

And whereas, after scrutiny of the application deficiency letter was issued to the institution on 13.05.2013 giving 60 days time to remove the deficiencies.

And whereas, reply dt. 09.07.2013 received on 16.07.2013 submitted by institution was placed in 188th meeting of WRC and the WRC considered the case carefully and committee decided to Recognition is rejected under clause 8(3) of the NCTE Regulations, 2009 issued on 29.08.2013.

And whereas, against Rejection letter, the institution preferred an appeal u/s 18 of NCTE Act, 1993 and the Appellate Authority vide its order no. 89-625/2013 Appeal/18th Meeting - 2013 A81225 dt. 13.01.2014 the Council hereby remands back the order of WRC.

And whereas, Appeal order dt. 13.01.2014 submitted by institution was placed in 190th meeting of WRC and the WRC considered the case carefully and committee decided to VT and VT report not received.

And whereas, a letter sent to the institution regarding compliance of NCTE Regulation 2014 on 23.12.2014.


And whereas, reply was submitted by the institution regarding acceptance of NCTE Regulations 2014 on 15.06.2015 which was placed in 222nd meeting of WRC and the Committee decided to VT be constituted.

And Whereas, the inspection of the institution was conducted on 16.08.2015.

And whereas, WRC considered visiting team report along with regulatory file and other relevant documents in 233rd meeting and committee decided to issue Clarification letter. Clarification letter was issued on 16.10.2015.

And whereas, reply dt. 29.10.2015 submitted by institution was placed in 245th meeting held on 01st - 03rd, 2016 and the Committee accepted the request of the institution for permit the closure of the application.

And now, therefore, the application of D.E.C.Ed. course is hereby Closed and FDRs, be returned.
