Whereas in terms of section 15 of the NCTE Act, 1993, Shri Ekta Education Trust, Plot Number: ACN 7/1, Street/Road: Androkha to Parosada Road, Village/Post office: Androkha, Tehsil/Taluka: Vijaynagar, District: Sabarkantha- 383460, Gujarat had submitted the application on 23.03.2015 to the Western Regional Committee of the NCTE for grant of recognition to B.Ed. College Androkha, Plot Number: 7/1, Street/Road - 7/1, Village/Post office: Androkha, Tehsil/Taluka: Vijaynagar, District: Sabarkantha- 383460, Gujarat.

And whereas, the proposal was examined and the Show Cause Notice letter was issued to the institution on 09.02.2016, and reply submitted by the institution, was received on 08.03.2016.

And whereas, the reply of SCN was placed in 247<sup>th</sup> meeting held on 04 - 06<sup>th</sup> April, 2016 and Committee decided to issue refusal order to the institution on the following points:-

"Show Cause Notice was issued to the institution on 09/02/2016 on seven grounds. The institution has replied vide letter dt. 18/02/2016. It is seen that the NOC from affiliating body is not submitted. Certified copy of the registered land documents is not submitted. Notarized copy of CLU is not submitted. Copy of building plan having demarcated built up area for existing B.Ed. course and proposed B.Ed. course not submitted. Further, the institution is not a composite one. Hence, Recognition is refused. FDRs if any, be returned."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to, B.Ed. College Androkha, Plot Number: 7/1, Street/Road - 7/1, Village/Post office: Androkha, Tehsil/Taluka: Vijaynagar, District: Sabarkantha- 383460, Gujarat.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 [www.ncte-india.org](http://www.ncte-india.org) to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
