Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Matrushree Santokba Shankarbhai B.Ed. College, Plot No. 1129, Palanpur, Banaskantha, Gujarat - 385001, had applied on 11.05.2015 in the Western Regional Committee, (NCTE), Bhopal for grant of permission for conducting additional unit of B.Ed. Course.

And whereas, after scrutiny of the application file was placed before WRC in its 235th held on 23th-24th November, 2015, the Committee decided as follows :-

"The case file was seen. The college applied online on 25.04.2015. However, the hard copy was received on 11.05.2015, which is more than the 15 days stipulated under the NCTE Regulations, 2014.

Hence, the application is summarily rejected and application fee paid be forfeited."

And whereas, the WRC vide rejection letter dt. 02.12.2015 was issued to the institution.

And whereas, the institution has filed a Writ Petition no. 4339/2016 before Hon'ble High Court of Gujarat, Ahmedabad and Hon'ble High Court of Gujarat has passed an order dt. 07.05.2016 which is as follows :-

"Considering the facts and circumstances of the case, the following order would meet the end of justice. The respondent no. 1 is hereby directed to reconsider the case of the petitioner Mandal for additional intake of basic unit of 50 students in accordance with law."

And whereas, the matter was placed before WRC in its 256th meeting held on July 19th - 21st, 2016 and the committee decided as follows :-

"The case file was seen. The WRO should process the case as per the order of the Hon'ble High Court of Gujarat at Ahmedabad."

And whereas, the WRC vide letter dt. 26.07.2016 was issued to the institution.

And whereas, the WRC vide letter dt. 26.07.2016, 24.10.2016 & 06.01.2017 was issued to the State Govt. for inviting recommendation for the application.

And whereas, no reply was received from the State Govt. and the matter was placed before WRC in its 276th meeting held on 30th - 31st, May 2017, and the committee decided as follows :-

"The case file was seen. The institution has applied for an additional unit of the B.Ed. course. The WRC is in receipt of a letter from the NCTE Hqrs. dt. 08/12/2016 which states that an institution cannot have more than 2 units of the B.Ed. course.

Hence, Show Cause Notice be issued to the institution as to why the Recognition should not be refused."

And whereas, a show cause notice dt. 05.06.2017 was issued to the institution.

And whereas, the institution vide letter no. S.S.Govinda/B.Ed./13/2017-18 dt. 21.06.2017 has submitted the documents on 28.06.2017 in response to show cause notice dt. 05.06.2017.

And whereas, reply dt. 21.06.2017 submitted by the institution was placed before the WRC in its 287th meeting held on 30th - 31st January, 2018 and the committee decided as follows :-

"The case file was seen. Show Cause Notice was issued to the institution on 05.06.2017 regarding the limitation of number of units in a particular course to two units. The institution has requested the NCTE not to consider the application for additional units.

Hence, Recognition is refused for additional unit."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of permission to Matrushree Santokba Shankarbhai B.Ed. College, Plot No. 1129, Palanpur, Banaskantha, Gujarat - 385001 for conducting additional unit of B.Ed. course.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order. The guidelines of appeal may be downloaded from the NCTE website.
