Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, Adeshwar Institute of Educational Technology, Plot No. 393, Village - Khamargaon, Post Office - Babu Semra, Tehsil/Taluka - Jagdalpur, District - Bastar, Chhattisgarh-494001 had submitted the application on 26.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to Adeshwar Institute of Educational Technology, Plot No. 393, Village - Khamargaon, Post Office - Babu Semra, Tehsil/Taluka - Jagdalpur, District - Bastar, Chhattisgarh-494001 for conducting B.Ed. course.

And whereas, the proposal was examined by WRC in its 241st meeting held on 4th-6th February, 2016 and the Show Cause Notice was issued to the institution on 13.02.2016, and reply was submitted by the institution on 08.03.2016.

And whereas, the reply of SCN was placed in 253rd meeting held on 24th-26th May, 2016 and the Committee decided to issue clarification on following grounds:-

"The case file was seen. Show Cause Notice was issued on 13/02/2016 and reply was received on 08/03/2016. An examination of the file shows that the land is in the name of an individual and not in the name of the Society. The Registration Certificate and Bye-laws of the Society have not been notarized. Notarized copy of the CLU from the SDM/SDO has not been submitted. Notarized copy of the Building Completion Certificate from Govt. Engineer has not been submitted.

Hence, Clarification be obtained on the above grounds".

And whereas, the clarification letter was issued to the institution on 10.06.2016, and reply was submitted by the institution on dt. 30.06.2016.

And whereas, the reply of clarification was placed in its 263rd meeting held on 25-27 November, 2016 and Committee decided issue refusal order to the institution on following points:-

"The case file was seen. An examination of the file shows that the Society has submitted a lease deed in the name of the Chairman of the Society. Private Lease deed is not permitted as per NCTE Regulations, 2014. The Society has not submitted notarized copy of the notarized copy of CLU, Building Completion Certificate issued by the competent authority. Further, the institution is not a composite one which is not permitted under Clause 2(b) of the NCTE Regulations, 2014.

In spite of multiple opportunities given to the institution it has not removed the deficiencies. Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to , B.Ed. course to Adeshwar Institute of Educational Technology, Plot No. 393, Village - Khamargaon, Post Office - Babu Semra, Tehsil/Taluka - Jagdalpur, District - Bastar, Chhattisgarh-494001.
