**WITHDRAWAL ORDER**

WHEREAS, the institution, namely **MMT COLLEGE OF EDUCATION, RUN BY NAV SURYODAY KALYAN SAMITEE, PLOT NO.01, STREET NO.02, VILLAGE- DOKARRANJI, POST OFFICE- BAGALI, TEHSIL/TALUKA- KEOLARI, TOWN/CITY/ DISTRICT- SEONI, PIN CODE- 480661, MADHYA PRADESH** had applied for grant of recognition for D.El.Ed course in the office of the Western Regional Committee of NCTE for the academic session 2016-2017.

AND WHEREAS, the case was processed and the Western Regional Committee of NCTE granted recognition to the institution for D.El.Ed. course vide order dated 02.05.2016 for 50 students.

Meanwhile, a complaint from one Shri Suresh Chandra, Social Worker, Village-Dokaranji, Tehsil-Kevlari was received in the office intimating "that no building has been constructed on the land numbering 297/1 of the village-Dokarranji. The management of the institution has got the inspection done showing another building. The complainant has also got the complaint endorsed by the Village Sarpanch and Patwari."

AND WHEREAS, the matter was considered by the WRC in its 248<sup>th</sup> Meeting held on April 11-12, 2016, and the Committee decided that before proceeding further, the copy of the complaint be sent to the Society to present its point of view. Accordingly, letter dated 20.04.2016 was sent to the institution to submit comments on the complaint. Reply submitted by the institution on 20.04.2016 alongwith an affidavit in this regard.

AND WHEREAS, the matter was considered by the WRC in its 250<sup>th</sup> Meeting held on April 27-28, 2016, and the Committee decided that since, the complaint is of serious nature, a copy of the complaint be forwarded to the Collector for enquiry and be requested to send the report as early as possible. Before issuance of letter, the Society sponsoring the institution submitted a Certificate dated 29/04/2016 from the Additional Collector, Seoni to the effect that in Khasra No. 297/1, construction of a three-storey building has been completed.

AND WHEREAS, the matter was considered by the WRC in its 251<sup>st</sup> Meeting held on April 30-May 2, 2016, and the Committee observed that the Society in its reply submitted a Certificate dated 29/04/2016 from the Additional Collector, Seoni to the effect that in Khasra No. 297/1, construction of a three-storey building has been completed. Hence, the Committee decided to grant Recognition to the institution.

AND WHEREAS, Madhyamik Shiksha Mandal vide letter dated 25.06.2016 has forwarded a letter dated 06.06.2016 received from Shri Paras Jain, Minister, Department of School Education, Madhya Pradesh, Bhopal to conduct an enquiry on the complaint made by Shri Suresh Chandra. Accordingly, letter dated 04.07.2016 was sent to the Collector, Seoni requesting to conduct an enquiry into the allegations made by the complainant and verify about the existence of the building on Khasra No.297/1 and submit a report/factual status in respect of the existence of MMT COLLEGE OF EDUCATION. It was also requested to verify the document/certificate dated 29/04/2016 issued by the Additional Collector, Seoni to the effect that on Khasra No. 297/1, a three-storey building has been completed and Certificate dated NIL issued by Patwari and Sarpanch to the effect that there is no building on Khasra No.297/1. Meanwhile, a report from the SDO, Keolari, Dist. Seoni, dt. 07/07/2016 has been received stating that there is no College building on Khasra No. 297/1, though a building is being constructed on it.

AND WHEREAS, the matter was again considered by WRC in its 256<sup>th</sup> meeting held on July 19-21, 2016 and the Committee decided that, "...a report has been received from the SDO, Keolari, Dist. Seoni, dt. 07/07/2016, stating that there is no College building on Khasra No. 297/1, though a building is being constructed on it. This is a very serious matter. Hence, the RD should write to Collector Seoni, sending both the documents - Additional Collector's Certificate and SDO's letter alongwith Tehsildar's Report and ask him for the factual position." Accordingly, letter dated 03.08.2016 was again sent to the Collector, Seoni requesting to conduct an enquiry into the allegations made by the complainant and verify about the existence of the building on Khasra No.297/1 and submit a report/factual status in respect of the existence of MMT COLLEGE OF EDUCATION, within one month from the date of this letter. It was also requested to verify the document/certificate dated 29/04/2016 issued by the Additional Collector, Seoni to the effect that on Khasra No. 297/1, a three-storey building has been completed and Certificate dated NIL issued by Patwari and Sarpanch to the effect that there is no building on Khasra No.297/1.


AND WHEREAS, Subsequently, a report was received from the Talathi and SDM, Keolari that there is no college building on Khasra No. 297/1 although a building is being constructed.

AND WHEREAS, the matter was placed before WRC in its 259<sup>th</sup> meeting held on September 21-23 2016 and the Committee decided that "...Complaints have been received from various quarters about the college regarding the fact that there is no building. The Recognition was given on the basis of a Certificate given by the Additional Collector, Dist. Seoni that a three story building has been constructed on Khasra No. 297/1. Subsequently, a report was received from the Talathi and SDM, Keolari that there is no college building on Khasra No. 297/1 although a building is being constructed. This entire matter was referred to the Collector, Dist. Seoni and the following facts have emerged :

- i) The SDM Keolari vide his letter dt. 21/07/2016 has confirmed that there is no building on Khasra No. 297/1.
- ii) The SDM has also expressed doubts about the correctness of the certificate issued by the Addl. Collector, Dist. Seoni dt. 29/04/2016. Doubts are also being raised about the certificate issued by the Addl. Collector, Dist. Seoni dt. 30/12/2014.
- iii) The management has also expressed its ignorance about the certificate issued by the Addl. Collector and it has no knowledge about it being sent to the WRO.

**Show Cause Notice be issued as to why the Recognition should not be withdrawn in view of the above. The reply should be received within 7 days. The Regional Director, WRO should write to the VT members calling their explanation on the recommendation which they have sent with their VT report giving the references cited above."** Accordingly, Show Cause Notice was issued to the institution on 26.09.2016.

AND WHEREAS, the reply received from the institution was placed before WRC in its 260<sup>th</sup> meeting held on October 13-15, 2016 and the Committee decided that "...This case refers to complaints received from various quarters that there is no building. Further documentary evidence were submitted from the Talathi Keolari that the building is under construction. This contradicts the Building Completion Certificate issued by the Sarpanch, Gram Panchayat-Dokaranji. Further, Recognition was given to the institution on 02/05/2016 on the basis of a letter from the additional Collector, Seoni. The veracity of the certificate from the additional Collector has been questioned. It is clear that, there was no building at the time of VT and the documents regarding the building submitted by the institution appear to be false. Show Cause Notice was issued to the institution regarding the above on 26/09/2016. The institution replied on 07/10/2016 but has not produced any documentary evidence. **Hence, Recognition is withdrawn under Section 17 of the NCTE Act, from the end of the academic session next following the date of withdrawal."**

NOW THEREFORE, the recognition granted to MMT COLLEGE OF EDUCATION, RUN BY NAV SURYODAY KALYAN SAMITI, 1, STREET/ROAD - 2, VILLAGE/TOWN/CITY-DOKARRANJI, POST OFFICE BAGALI, TEHSIL/TALUKA - KEOLARI, TOWN/CITY/DISTRICT-SEONI, PIN CODE - 480661, MADHYA PRADESH for conducting D.El.ED course vide order dated 02.05.2016 is hereby withdrawn under section 17 of the NCTE Act, 1993, from the end of the academic session next following the date of withdrawal.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
