Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Kanti Darshan Shaikshanik and Computer Training Institute, Plot/Khasra Number - 24/2-3, Village - Kosa Nagar, Post Office - Nehru Nagar, Tehsil/Taluka - Durg, District - Durg, Chhattisgarh - 490020 had submitted the application on 30.05.2015 to the Western Regional Committee of the NCTE for grant of recognition to Kanti Darshan Shaikshanik and Computer Training Institute, Plot/Khasra Number - 24/2-3, Village - Kosa Nagar, Post Office - Nehru Nagar, Tehsil/Taluka - Durg, District - Durg, Chhattisgarh - 490020 for conducting M.Ed. course.

And whereas, the proposal was examined by WRC in its 241st meeting held on 4th-6th February, 2016 and the Show Cause Notice was issued to the institution on 11.02.2016, and reply was submitted by the institution on 24.02.2016.

And whereas, the reply of SCN was placed in 247th meeting held on 4th-6th April, 2016 and the Committee decided to constitute visiting team.

And whereas, the inspection of institute was conducted on 17.04.2016.

And whereas, the visiting team report along with other document, was placed before the WRC in its 250th meeting of WRC held on 27th-28th April, 2016 and Committee decided to issue Show Cause Notice letter was issued on dt. 05.05.2016.

And whereas, reply of show cause notice dt. 30.04.2016 received in this office on 01.05.2016, was placed before the WRC in its 263rd meeting held on 25th-27th November, 2016 and Committee decided to issue refusal order to the institution on following points:-

"The case file was seen. Show Cause Notice was issued to the institution on 05/05/2016 regarding the size of the multipurpose hall, ill equipped Laboratory, and inadequacy of the total built up area.

The institution has not satisfactorily replied to the points of the Show Cause Notice.

Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to , M.Ed. course to Kanti Darshan Shaikshanik and Computer Training Institute, Plot/Khasra Number - 24/2-3, Village - Kosa Nagar, Post Office - Nehru Nagar, Tehsil/Taluka - Durg, District - Durg, Chhattisgarh - 490020.
