ORDER

WHEREAS, WRC, NCTE had granted recognition to GURUKUL COLLEGE OF EDUCATION, PLOT/KHASRA NO- 71/KA/2, STREET NO: AMLA-SARWA ROAD, VILLAGE- GRAM SAMASPURA, RATIBAD ROAD, POST OFFICE- SURAJ NAGAR, BHADBHADA ROAD, CITY- BHOPAL, TEHSIL- HUZUR, DISTRICT- BHOPAL, 462044, MADHYA PRADESH vide order dated 29.02.2016 to start the **B.ED.** course with an annual intake of 100 students (two units of 50 students each).


AND WHEREAS, a letter was submitted by the institution on 19.12.2016 & 31.07.2017 with a affidavit and request of resolution passed by society for closure of one unit of B.Ed. course from the academic session 2017-18.

AND WHEREAS, the matter was placed in 259th Meeting of WRC held on September 21-23, 2016 and the Committee decided that "... Institutions which have requested for reducing intake may be permitted."

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Now, therefore, the intake of the institution for conduct of B.Ed. course is hereby permitted to reduce the intake of 100 students (2 basic units) to 50 students (one unit.)
