Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Bhilai Education Trust, Plot No.- 62/001, Street Road - Hospital Sector, Town City - Bhilai, Durg, Chhattisgarh-490009 had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Bhilai Mahila Mahavidhyalaya, Plot No. - 62/001, Post Office - Hospital Sector, Town City - Bhilai Nagar, Durg, Chhattisgarh-490009 for conducting M.Ed. Course.

And whereas, the proposal was examined by WRC in its 241st meeting held on 4th-6th February, 2016 and the Show Cause Notice was issued to the institution on 13.02.2016, and reply was submitted by the institution on 09.03.2016.

And whereas, the matter was placed before the WRC in its 264th meeting held on 14th-15th December, 2017 and Committee decided as follows :-

"The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

And whereas, file of the institution scrutinized by the WRO as per decision of 264th meeting held on 14th-15th December, 2017.

And whereas, the matter was placed before the WRC in its 266th meeting held on January 10th-12th, 2017 and Committee decided as follows :-

"The case file was seen. Consequent to the issue of Show Cause Notice to the institution on 13/02/2016, the following deficiencies still exist:-

- a) The Lease deed issued by the Asst. Manager, SAIL is dt. 07/04/1981 and valid for 30 years. The validity of the lease has expired.*
- b) The approved Building Plan has still not been submitted.*

Compliance in this matter should be submitted within 30 days. As soon as the valid documents are received, VT be constituted".

And whereas, Conveying decision letter was issued to the institution on 17.01.2017 and reply was submitted by the institution on 06.02.2017 and 02.03.2017.


And whereas, the matter was placed before the WRC in its 271st meeting held on March 23-25, 2017 and Committee decided as follows :-

"The case file was seen. Since the extension of lease is under consideration, the case can be considered only after the lease is extended".

And whereas, Conveying decision letter was issued to the institution on 31.03.2017 and reply of Conveying decision letter was not submitted by the institution to till date.

And whereas, the matter was placed before the WRC in its 283rd meeting held on 14th-15th November, 2017 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued to the institution on 17.01.2017 regarding expiry of lease deed and non-approval of Building plan. Since the institution has not complied with the Show Cause Notice, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to M.Ed. course to Bhilai Mahila Mahavidhyalaya, Plot No.-62/001, Post Office - Hospital Sector, Town City - Bhilai Nagar, Durg, Chhattisgarh-490009.**

Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of NCTE Act 1993 www.ncte-india.org to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 through online mode against this order within 60 days of the issue of this order.
