Refusal Order

Whereas in terms of section 15 of the NCTE Act, 1993, Bhilai Education Trust, Plot No.- 62/001, Street Road - Hospital Sector, Town City - Bhilai, Durg, Chhattisgarh-490009 had submitted the application on 29.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Bhilai Mahila Mahavidyalaya, Plot No. -62/001, Post Office-Hospital Sector, Town City - Bhilai, Durg, Chhattisgarh - 490009 for conducting D.El.Ed. Course.

And whereas, the proposal was examined by WRC in its 236th meeting held on December 15th - 16th, 2015 and Committee decided as follows :-

"The case file was seen. The application was submitted online on 29.06.2015, whereas the hard copy has been received on 15.07.2015.

As per rule 7(2)(a)(b) of NCTE Regulations, 2014, the application is summarily rejected because it has not been submitted within 15 days of the submission of the online application".

And whereas, Rejection letter was issued to the institution on 01.01.2016.

And whereas, institution was file an appeal before the Appeal Committee, NCTE, New Delhi on 23.02.2016 and Appeal Committee had decided the appeal of institution on 09.06.2016 with the direction of " the Council hereby remands back the case of Bhilai Mahila Mahavidyalaya, Bhilai, Durg, Chhattisgarh to the WRC, NCTE for necessary action as indicated above".

And whereas, the matter was placed before the WRC in its 264th meeting held on 14th-15th December, 2017 and Committee decided as follows :-

"The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

And whereas, file of the institution scrutinized by the WRO as per decision of 264th meeting held on 14th-15th December, 2017.

And whereas, the matter was placed before the WRC in its 271st meeting held on 23rd-25th March, 2017 and Committee decided as follows :-

"The case file was seen. Since the extension of lease is under consideration, the case can be considered only after the lease is extended."

And whereas, Conveying decision letter was issued to the institution on 31.03.2017 and reply of Conveying decision letter was not submitted by the institution to till date.

And whereas, the matter was placed before the WRC in its 283rd meeting held on 14th-15th November, 2017 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued to the institution on 17.01.2017 regarding expiry of lease deed and non-approval of Building plan. Since the institution has not complied with the Show Cause Notice, Recognition is refused."
