WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, RAM DAYAL GENDA BAI SHIKSHA MAHAVIDHYALAYA, KHASRA NO.287 PLOT NO. PHN33, VILLAGE MALIKHADI, P.O. NEELBAD, TEHSIL HUZUR, DIST. BHOPAL – 462003, MADHYA PRADESH under section 14(3)(a) of NCTE Act, 1993 for conducting D.El.Ed. course of two years duration with an annual intake of 50 students vide order dated 31.08.2012.

AND WHEREAS, Madhyamik Shiksha Mandal vide letter dated 30.05.2015 has forwarded a complaint against the institution.

AND WHEREAS, the matter was placed before WRC in its 229th meeting held on July 21-22, 2015 and the Committee observed that "...The Secretary, Madhyamik Shiksha Mandal has forwarded a complaint vide its letter dated 30.05.2015 made by NSUI, Bhopal against the Ram Dayal Genda Bai Shiksha Mahavidhyalaya, Bhopal. According to the complaint letter dated 14.05.2015, the institution does not have its own building and hence, the institution cannot run educational activities. The complainant has asked to derecognize the college and register criminal case against the institution. The complaint letter addressed to the Secretary, Madhyamik Shiksha Mandal has been forwarded to Regional Director for taking decision on Recognition and filing criminal case against the institution. The Committee considered the matter and decided that the case be referred to NCTE Hqrs to conduct inspection u/s 13 of the NCTE Act, 1993." Accordingly, file was sent to NCTE Hqrs. vide letter dated 31.07.2015.

AND WHEREAS, the inspection of the institution was conducted u/s 13 on 10.02.2016.

AND WHEREAS, the original file, visiting team report and other relevant documents was placed before the WRC in its 253rd meeting held on May 24-26, 2016 and the Committee observed that "...The Madhyamik Shiksha Mandal vide letter dt. 30/05/2015 had informed the WRC that the institution does not have a building of its own in Neelbad. Inspection u/s 13 was conducted on 10/02/2016 and VT report was received on 14/03/2016. The VT has mentioned that the building is under construction and there were no equipments, books, students or staff. Hence, Show Cause Notice be issued under section 17, on the above grounds." Accordingly, Show Cause Notice was issued on 17.06.2016.

AND WHEREAS, reply received from the institution was placed before WRC in 280th meeting held on August 31- September 1, 2017 and the Committee observed that "...WRC in its 229th meeting held on July 21-22, 2015 had observed that the building was under construction. Again, the WRC in its 253rd meeting held on May 24-26, 2016 had again observed that the VTR had mentioned that the building is still under construction. Thereafter, show cause notice was issued to the institution on 17.06.2016. The institute has not been able to submit the required documents regarding completion of building. Hence, Recognition is withdrawn from the session 2018-2019. FDR, if any, be returned."

NOW THEREFORE, the recognition granted to RAM DAYAL GENDA BAI SHIKSHA MAHAVIDHYALAYA, KHASRA NO.287 PLOT NO. PHN33, VILLAGE MALIKHADI, P.O. NEELBAD, TEHSIL HUZUR, DIST. BHOPAL – 462003, MADHYA PRADESH for conducting D.El.Ed. course vide order dated 31.08.2012 is hereby withdrawn under section 17(1) of the NCTE Act, 1993 from the academic session 2018-2019.
