Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, Vivekanada Institute of Education, Plot No. 146, Street No.-Kota, Village-Kota, Post Office-Pt. Ravishankar Shukla University, Tehsil/Taluka-Raipur, District-Raipur, Chhattisgarh-492010 had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Vivekanada Institute of Education, Plot No. 146, Street No.-Kota, Village-Kota, Post Office-Pt. Ravishankar Shukla University, Tehsil/Taluka-Raipur, District-Raipur, Chhattisgarh-492010 for conducting D.El.Ed. course.

And whereas, the proposal was examined by WRC in its 241st meeting held on 4th-6th February, 2016 and the Show Cause Notice was issued to the institution on 09.02.2016, and reply was submitted by the institution on 11.03.2016.

And whereas, the reply of SCN was placed in 253rd meeting held on 24th-26th May, 2016 and the Committee decided to issue clarification on following grounds:-.

"The case file was seen. Show Cause Notice was issued on 11/02/2016 and reply was received on 11/03/2016. An examination of the file shows that the institution has submitted all the required documents. However, it is seen that the total built up area is only 3163.88 sq. mtrs which is insufficient for running existing two units of the B.Ed. course and proposed one unit of D.El.Ed. course (requirement is 3500 sq. mtrs.).

Hence, Clarification be obtained on the above ground."

And whereas, the clarification letter was issued to the institution on 10.06.2016, and reply was submitted by the institution on dt. 24.06.2016 & 28.06.2016.

And whereas, the reply of clarification was placed in its 263rd meeting held on 25-27 November, 2016 and Committee decided issue refusal order to the institution on following points:-

"The case file was seen. After the issue of Show Cause Notice, a clarification letter was issued on 10/06/2016 and reply was received on 24/06/2016 and 28/06/2016. The clarification letter referred to the insufficiency of built up area.

The institution by way of reply has submitted a Building Plan signed by a private engineer which is not acceptable.

Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to, D.El.Ed. course to Vivekanada Institute of Education, Plot No. 146, Street No.-Kota, Village-Kota, Post Office-Pt. Ravishankar Shukla University, Tehsil/Taluka-Raipur, District-Raipur, Chhattisgarh-492010.
