Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, Chouksey College of Education, Plot No. 217/2, Street No. – Near NH-200, Village-Mahamand, Post Office-Mahamand, Tehsil/Taluka-Bilaspur, District-Bilaspur, Chhattisgarh-495004 had submitted the application on 30.06.2015 to the Western Regional Committee of the NCTE for grant of recognition to Chouksey College of Education, Plot No. 217/2, Street No. – Near NH-200, Village-Mahamand, Post Office-Mahamand, Tehsil/Taluka-Bilaspur, District-Bilaspur, Chhattisgarh-495004 for conducting B.Ed. course.

And whereas, the proposal was examined by WRC in its 241st meeting held on 4th-6th February, 2016 and the Show Cause Notice was issued to the institution on 16.02.2016, and reply was submitted by the institution on 16.03.2016.

And whereas, the reply of SCN was placed in 253rd meeting held on 24th-26th May, 2016 and the Committee decided to issue clarification on following grounds:-

"The case file was seen. Show Cause Notice was issued on 16/02/2016 and reply was received on 16/03/2016. An examination of the file shows that the institution is not fulfilling Clause 2(b) of the NCTE Regulations, 2014. The Society's College of Engineering is a separate Educational institution.

Hence, Clarification be obtained on the above ground."

And whereas, the clarification letter was issued to the institution on 10.06.2016, and reply was submitted by the institution on dt. 28.06.2016.

And whereas, the reply of clarification was placed in its 263rd meeting held on 25-27 November, 2016 and Committee decided issue refusal order to the institution on following points:-

"The case file was seen. Show Cause Notice was issued to the institution on 16/02/2016 and reply received on 16/03/2016. Thereafter, clarification letter was issued regarding the fact that the institution is not a composite institution which is not permitted under Clause 2(b) of the NCTE Regulations, 2014.

The letter from the management of institution confirms that it is a stand alone institution. Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuses grant of recognition to , B.Ed. course to Chouksey College of Education, Plot No. 217/2, Street No. – Near NH-200, Village-Mahamand, Post Office-Mahamand, Tehsil/Taluka-Bilaspur, District-Bilaspur, Chhattisgarh-495004.
