Refusal Order

Whereas in terms of section 14 of the NCTE Act, 1993, DIET Narayanpur, Village - Singoditarai, Main Road Narayanpur, District - Baster, Chhattisgarh, had submitted the application on 30.05.2016 to the Western Regional Committee of the NCTE for grant of recognition to DIET Narayanpur, Village - Brehbeda, Sonpur Road, Taluka/Mandal-Naraynpur, Town/City-Brehbeda, District - Baster, Chhattisgarh - 494661 for conducting D.El.Ed. course of 2 years duration.

And whereas, the proposal was examined by WRC in its 267th meeting held on 23rd-25th January, 2017 and the Committee decided to issue Show Cause Notice on following points:-

"The case file was seen. An examination of the documents shows the following deficiencies:-

- a) The institution does not fulfill the requirement as per clause 2(b) and 3(a) of the NCTE Regulations, 2014 according to which every teacher education institution has to be a composite one.

Hence, Show Cause Notice be issued to the institution on the above ground. Reply should be submitted within 30 days.

Accordingly show cause notice was issued to the institution on 01.02.2017 and reply was not submitted by the institution till date.

And whereas, the matter was placed before the WRC in its 287th meeting held on 30th-31st January, 2018 and Committee decided to issue refusal order to the institution on the following points:-

"The case file was seen. Show Cause Notice was issued to the institution on 01.02.2017. The institution has not replied so far.

Hence, Recognition is refused."

Now, therefore, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of recognition to D.El.Ed. course to DIET Narayanpur, Village - Brehbeda, Sonpur Road, Naraynpur, District - Baster, Chhattisgarh - 494661.**

Further, if the institution is not satisfied by the decision, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this decision under section 18 of NCTE Act 1993 within 60 days of the issue of this letter through online mode, on the NCTE website www.ncte-india.org.
