**Refusal Order**

Whereas in terms of section 15 of the NCTE Act, 1993, Govt. College of Education (IASE), Khasra No. - 222/3 and 222/4, Link Road, Bilaspur, Chhattisgarh - 459001 had submitted an application on 25.05.2016 to the Western Regional Committee of the NCTE for grant of permission to Govt. College of Education (IASE), Khasra No. - 222/3 and 222/4, Link Road, Bilaspur, Chhattisgarh - 459001 for conducting D.El.Ed. course of 2 years duration.

And whereas, the proposal was examined by WRC in its 264<sup>th</sup> meeting held on 14<sup>th</sup>-15<sup>th</sup> December, 2016 and the Committee decided to constitute visiting team.

And whereas, the inspection of institute was conducted on 24.01.2017.

And whereas, the visiting team report along with other documents, was placed before the WRC in its 268<sup>th</sup> meeting of WRC held on 9<sup>th</sup>-11<sup>th</sup> February, 2017 and Committee decided to issue clarification to the institution on following points:-

*"The case file was seen. The institution is already running the B.Ed. course (213004) with 3 units and the M.Ed. course with 1 unit. The CD could not be viewed as it was found damaged.*

*The institution be asked to submit a fresh CD / Pendrive in working condition.*

*Hence, Clarification be obtained on the above grounds. Reply should be submitted within 30 days."*

Accordingly clarification letter was issued to the institution on 14.02.2017 and reply was submitted by the institution on 07.03.2017.

And whereas, the matter was placed before the WRC in its 271<sup>st</sup> meeting held on 23<sup>rd</sup>-25<sup>th</sup> March, 2017 and Committee decided to issue show cause notice to the institution on the following points:-

*"The case file was seen. VT visited the institution on 24.01.2017. VTR was perused and the CD was viewed. CD shows a good building with good infrastructural and instructional facilities. However, the built up area is 2594 sq.mts. whereas, the requirement for three units of B.Ed. and one unit of M.Ed. and one unit of the proposed D.El.Ed. is 4500 sq.mts.*

*Hence, Show Cause Notice be issued on the above grounds."*

Accordingly show cause notice was issued to the institution on 31.03.2017 and reply was not submitted by the institution till date.

And whereas, the matter was placed before the WRC in its 287<sup>th</sup> meeting held on 30<sup>th</sup>-31<sup>st</sup> January, 2018 and Committee decided to issue refusal order to the institution on the following points:-

*"The case file was seen. Show Cause Notice was issued to the institution on 31.03.2017 regarding the paucity of built up area. Reply has not been received so far.*

*Hence, Recognition is refused."*

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, **the Western Regional Committee hereby refuses grant of permission of D.El.Ed. course to Govt. College of Education (IASE), Khasra No. - 222/3 and 222/4, Link Road, Bilaspur, Chhattisgarh - 459001.**

Further, if the institution is not satisfied by the decision, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this decision under section 18 of NCTE Act 1993 within 60 days of the issue of this letter through online mode, on the NCTE website www.ncte-india.org.
