Whereas, in terms of section 15 of the NCTE Act, 1993, Pratibha Educational Academy Pvt. Ltd., Balsi, Saraipali, Mahasamund, Chhattisgarh - 493558 had submitted the application on 30.06.2016 to the Western Regional Committee of the NCTE for grant of permission to Pratibha College of Education, Village – Balsi, Sarsiwa Road, Saraipali, Mahasamund, Chhattisgarh-493558 for conducting D.El.Ed. course of 2 years duration.

And whereas, the proposal was examined by WRC in its 264^{th} meeting held on $14^{th}-15^{th}$ December, 2017 and Committee decided as follows:-

"The WRO has scrutinized 69 files of the new applications for the academic session 2017-2018. Where the applications are complete for VT, the WRO should send the VT immediately."

And whereas, the email dt. 28.01.2017 was sent to institution and VT members for conducting inspection of the institution.

And whereas, Dr. Anshu Tripathi, VT Member vide email dt. 05.02.2018 has informed that the Pratibha College of Education, Village – Balsi, Sarsiwa Road, Saraipali, Mahasamund, Chhattisgarh-493558 has refused the inspection as following grounds:-

"We have applied for D.El.Ed. course last year which was under process, for that LOI has been issued in 268th, 9-11 February, 2017 meeting. We have applied again for the safe side for which inspection has been scheduled. So as letter of intent (LOI) has been issued inspection is not needed."

And whereas, the matter was placed before the WRC in its 288th meeting held on February 15-16, 2018 and Committee decided as follows:-

"The case file was seen. Application of the college Code No.APP2703 has already been granted recognition for the D.El.Ed. course. The current application under Code No.APP9283 is duplicate application which should not be processed further and the file be closed."

Now, therefore, in exercise of the powers vested under section 15 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refuse grant of permission of D.El.Ed. course to Pratibha College of Education, Village – Balsi, Sarsiwa Road, Saraipali, Mahasamund, Chhattisgarh-493558.

Further, if the institution is not satisfied by the decision, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this decision under section 18 of NCTE Act 1993 within 60 days of the issue of this letter through online mode, on the NCTE website www.ncte-india.org.
