ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to Samata Shikshan Prasarak Mandal, Junior College of Education At. Post, Paranda, Ta. Paranda, osmanabad, Maharashtra (APW01312/112211) vide order No. - WRC/2-32/112211/77(con)/2005/7638 for conducting D.El.Ed. course with an annual intake of 50 students.

AND, WHEREAS, the institution vide letter dated 22.06.2016 requested to close the D.El.Ed course.

AND, WHEREAS, the matter was placed before the WRC in its 258thWRC meeting held on August 22-24, 2016, The Committee decided as under:-

"...The Samata Shikshan Prasarak Mandal junior College of Education was recognized for an additional intake of 50 students vide order No. WRC/2-32/12211/(con)/2005 dt. 26/09/2005. The institution has informed that it has already closed two division of D.Ed. earlier, and wants to close one more division because students are not available.

A photocopy of the English translation of the Resolution has been submitted. Also, an NOC of the MSCERT, Pune of Govt. Maharashtra dt. 31/10/2015 has also been submitted showing that NOC has been granted and withdrawal of Recognition of additional unit of D.Ed. has been recommended.

Hence, Closure is permitted. FDRs if any, be returned."

Now, therefore, the request of the institution for closure of the D.El.Ed. course is hereby accepted and file closed.
