ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to Al-Inam-Madarasa & Education Welfare Society, Wahed Khan Urdu D.Ed. College S.No.-4/4, Maoje Ghambhirpur, Amravati-444601, Maharashtra (APW02336/122220) vide order No.-WRC/5-6/93/2006 dt-13.02.2007 for conducting D.El.Ed. course with an annual intake of 50 students.

AND, WHEREAS, the institution vide letter dated 14.06.2016 requested to close the D.El.Ed course.

AND, WHEREAS, the matter was placed before the WRC in its 258thWRC meeting held on August 22-24, 2016, The Committee decided as under:-

"...The Al Inam Madarsa and Education Welfare Society was recognized for D.Ed. course vide WRC/5-6/93/2006 dt. 13.02.2007. Though no Resolution has been submitted, the No Objection Certificate from Director, MSCERT, Pune of the Govt. of Maharashtra dt. 14/06/2016 has been submitted which has given NOC "...and recommends to withdraw Recognition of concerned additional division of 50 intake of Teacher Education programme which is granted by WRC Bhopal by its order No. WRC/5-6/93/2006 dt. 13.02.2007 date 13.02.2007 from the academic year 2015-16...".

Hence, Closure is permitted. FDRs if any, be returned."

Now, therefore, the request of the institution for closure of the D.El.Ed.course is hereby accepted and file closed.
