WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, HICT SHIKSHA MAHAVIDYALAYA, KHASRA NO.514, HALKA NO.45, GRAM ADUPURA, DABRA ROAD, GWALIOR, MADHYA PRADESH for conducting D.Ed. course of two years duration with an annual intake of 50 students vide order dated 17.12.2006 and thereafter permission for additional intake of 50 seats was granted vide order dated 23.12.2015.

AND WHEREAS, the Madhyamik Shiksha Mandal, Bhopal vide letter dated 18.08.2017 has forwarded the report from the Collector, Gwalior, regarding complaints about the institution.

AND WHEREAS, the matter was placed before WRC in its 280th meeting held on August 31-September 1, 2017 and the Committee decided that "...Madhyamik Shiksha Mandal, Bhopal vide letter dt. 18.08.2017 forwarded the report from Collector, Gwalior regarding complaints about the institution. The investigation by the Collector was done as per direction of the Hon'ble High Court of M.P. Bench at Gwalior in W.P. No. 411/2016. The report has recommended that the recognition for the D.El.Ed. Course be withdrawn. Show Cause Notice be issued as to why the recognition of the course should not be withdrawn. Reply should be received within 21 days." Accordingly, Show Cause Notice was issued on 06.09.2017.

AND WHEREAS, the reply received from the institution was placed before WRC in its 285th meeting held on December 19-21, 2017 and the Committee decided that "...The Hon'ble High Court of Madhya Pradesh, Gwalior Bench in the Review Petition No.411/2016 had directed that the Collector of Gwalior conduct an enquiry into the allegations made by students. The Collector submitted the report to the Madhyamik Shiksha Mandal vide letter dated 25.07.2017 recommending the closure of the D.Ed. course. Show Cause Notice was already issued in this case on 06.09.2017. There has not been any substantive reply from the institution. **Therefore, Recognition is withdrawn from the academic session 2018-2019.**"

NOW THEREFORE, the recognition granted to **HICT SHIKSHA MAHAVIDYALAYA, KHASRA NO.514, HALKA NO.45, GRAM ADUPURA, DABRA ROAD, GWALIOR, MADHYA PRADESH** for conducting D.Ed. course vide order dated 17.12.2006 and thereafter permission for additional intake of 50 seats granted vide order dated 23.12.2015 and is hereby withdrawn under section 17(1) of the NCTE Act, 1993 from the academic session 2018-2019.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
