WITHDRAWAL ORDER

Whereas, the WRC had granted the recognition to **Bhartiya Gramin Vikas Mandals Shri Chh Shivaji College of Physical Education, N.H-9 At Post Tah-Mohol City: Solapur, Maharashtra** for conducting B.P.Ed. Course of one year duration for the academic session 2000-2001 with an annual intake of 50 students vide order no. WRC/5-6/2K/11460-466 dt. 15.12.2000.

And whereas, NCTE Regulations 2014 promulgated in Nov, 28.2014. This office has conveyed your institution requesting to submit an affidavit for adherence of clause or provision mention in the NCTE Regulations 2014 vide letter dt. 23.01.2015, but your institution failed to submit the compliance.

And whereas, the matter was placed before the committee in its **286th** meeting which was held on 16-17 January 2018 and the committee took decision as under:-

"The case file was seen. The institution was asked vide letter dated 23.01.2015 for submitting an affidavit to abide by the NCTE Regulations, 2014, failing which the Recognition of the institution would stand withdrawn. The institution has not replied.

Therefore, the name of the institution is struck off from the rolls of the recognized institutions."

Now, therefore, the name of the institution is struck off from the rolls of the recognized institutions name, Bhartiya Gramin Vikas Mandals Shri Chh Shivaji College of Physical Education, N.H-9 At Post Tah-Mohol City: Solapur, Maharashtra for (50 students) of the B.P.ED course in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
