WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely, SHRI RAMNATH SINGH INSTITUTE OF PHYSICAL EDUCATION, NEAR SITHOLI, RAILWAY STATION, JHANSI ROAD, GWALIOR 475001 MADHYA PRADESH under section for conducting B.P.Ed. course of two years duration with an annual intake of 50 students vide order dated 18.12.2006.


AND WHEREAS, in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) issued the revised recognition order dated 16.05.2015 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students (one basic unit with two section of 50 (fifty) each) from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

AND WHEREAS, the case of B.Ed. course was placed before WRC in its 263rd meeting held on November 25-27, 2016 and the Committee decided that "...The case file was seen. Clarification letter was issued on 20/10/2016. On the basis of the reply letter from the Collector, Gwalior dt. 17/11/2016, it is seen that the institution has the required land and building to the run the B.Ed. course. Hence, no further action is required. With regard to the B.P.Ed. course, the management has expressed a view that it is not running the course since 2015-2016 and has no intention to run it further. To enable the WRO to close the B.P.Ed. file, the management be asked to submit a Resolution for closure of the B.P.Ed. Course. Compliance in the above matter should be submitted within 30 days." Accordingly, Letter was issued on 02.02.2017.

AND WHEREAS, the matter was again placed in WRC in its 270th meeting held on March 1-3, 2017 and the Committee decided that "...The institution had expressed the view that it is not running the B.P.Ed. course nor does it intend to do so. However, inspite of clarification for submitting a resolution for closing the B.P.Ed. course, the institution has not submitted any reply. Hence, Show Cause Notice be issued as to why the recognition should not be withdrawn on the above grounds. Reply should be submitted within 30 days." Accordingly, Show Cause Notice was issued on 03.04.2017.

AND WHEREAS, the reply received from the institution was placed before WRC in its 286th meeting held on January 16-17, 2018 and the Committee decided that "...The management has stated that it is not running the B.P.Ed. course since 2015-2016 and has no intention to run it further. This has also been confirmed vide letter dated 09.05.2017 from the institution. **Hence, Recognition for the B.P.Ed. course is withdrawn from the academic session 2018-2019.**"

NOW THEREFORE, the recognition granted to SHRI RAMNATH SINGH INSTITUTE OF PHYSICAL EDUCATION, NEAR SITHOLI, RAILWAY STATION, JHANSI ROAD, GWALIOR 475001 MADHYA PRADESH for conducting B.P.Ed. course vide order dated 18.12.2006 is hereby withdrawn from the academic session 2018-2019 under section 17(1) of the NCTE Act, 1993.
