WITHDRAWAL ORDER

WHEREAS, recognition has been granted to the institution namely, MAHARISHI MAHAVIDYALAYA, RUN BY - MAHARISHI SHIKSHA SANSTHA, MAHARISHI ASHRAM, VILL : SARRA, PO. IMLIKHEDA, CHHINDWARA-480001, MADHYA PRADESH for conducting B.P.Ed. course of two years duration with an annual intake of 50 students vide order dated 11.09.2008.

AND WHEREAS, NCTE promulgated the National Council for Teacher Education, 2014 and issued guidelines for sending letter to the recognized institutions for submission of affidavit for compliance of NCTE Regulations, 2014.

AND WHEREAS, An Explanatory Note on implications of the New Regulations for the existing Teacher Education Institutions was forwarded to the institution vide letter dated **23.01.2015** and was advised to take the required action at the earliest and intimate the same to the office within 21 days from the date of receipt of this letter alongwith the affidavit in the prescribed format, failing which the revised order of recognition will not be issued and the recognition granted earlier will become invalid.

AND WHEREAS, the affidavit for compliance of NCTE Regulations, 2014 has not been submitted by the institution. Hence, Revised order was not issued to the institution.

AND WHEREAS, the matter was placed before the WRC in its 255th meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted affidavits for compliance of NCTE Regulations, 2014. Accordingly, Show Cause Notice was issued to the institution on 12.04.2017.

AND WHEREAS, reply not received from the institution. The matter was placed in 288th WRC meeting held on February 15-16, 2018 and the Committee observed that "...The institution was required to submit an affidavit to abide by the NCTE Regulations, 2014. Since the institution did not submit the affidavit, Show Cause Notice was issued on 12.04.2017. Reply has not been received till date. **Hence, Recognition is withdrawn from the academic session 2018-2019.**"

NOW THEREFORE, the recognition granted to MAHARISHI MAHAVIDYALAYA, RUN BY - MAHARISHI SHIKSHA SANSTHA, MAHARISHI ASHRAM, VILL : SARRA, PO. IMLIKHEDA, CHHINDWARA 480001, MADHYA PRADESH for conducting B.P.Ed. course vide order dated 11.09.2008 is hereby withdrawn from the academic session 2018-2019 under section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
