Whereas, in terms of section 14 of the NCTE Act, 1993, WRC granted recognition to **Parivartan Gramin Vikas Mahila Va Shikshan Mandals, Shri Ramkrishna College of Education, Saraswati Complex, Basmath Road, Parbhani-432401, Maharashtra** for D.Ed. course of Two year duration with an annual intake of 50 students vide order No. WRC/5-6/100th/2007/C-27599 dated 25.01.2008

And whereas, the institution applied for Shifting of premises on 18.01.2012 received in this office from "Parivartan Gramin Vikas Mahila Va Shikshan Mandals, Shri Ramkrishna College Of Education, Saraswai Complex, Basmath Road, Parbhani-432401, Maharashtra", to "Parivartan Gramin Vikas Mahila Va Shikshan Mandals, Block No.08, Plot No. 73, Hasnapur Dist-Parbhani".

And whereas, a deficiency letter was issued to the institution on 17.01.2015.

And whereas, the institution replied vide letter dated 15.09.2015, received in this office on 19.09.2015.

And whereas, the matter was placed before the WRC in its 284th meeting held on 28th - 29th November, 2017. The Committee decided as under:-

The case file was seen. This is a case of shifting.

An examination of the file shows that the institution has not submitted CLU from Revenue Officer (SDO) and Building Completion Certificate in the prescribed format issued by a Govt. Engineer.

Since Regulations, 2014 are in operation now, the institution be asked to submit all the documents certified by the competent authorities and the remaining fee as per NCTE Regulations, 2014. Total fee is Rs.1.50 lakhs.

The institution is required to submit FDRs for Rs.12.00 lakhs (in joint name).

The institution should submit latest list of faculty members as per NCTE Regulations, 2014 duly approved by the competent authority.

Hence, Show Cause Notice be issued to the institution as to why recognition should not be withdrawn. Reply should be submitted within one month.

And whereas, The Show cause notice letter issued to the institution on 08.12.2017 to fulfil the conditions and decision of the committee.

And whereas, the institution submit reply to the Show Cause Notice on dt 05.01.2018.

And whereas, the matter was placed before the WRC in its 286th meeting held on 16th - 17th January, 2018. The Committee decided as under:-

The case file was seen. Show Cause Notice was issued to the institution on 08.12.2017 and reply was received on 05.01.2018. The institution has not submitted CLU from Revenue Officer, Building Completion Certificate in the prescribed format from the Govt. Engineer, Staff list, and additional FDR of Rs.4.00 lakhs.

Therefore, shifting of premises is not permitted and Recognition is withdrawn from the academic session 2018-2019.


Additional fees of Rs.1.10 lakhs and FDRs, if any, be returned to the institution.

Now, therefore, the permission for change of premises is not permitted from Parivartan Gramin Vikas Mahila Va Shikshan Mandals, Shri Ramkrishna College Of Education, Saraswai Complex, Basmath Road, Parbhani-432401, Maharashtra", to "Parivartan Gramin Vikas Mahila Va Shikshan Mandals, Block No.08, Plot No. 73, Hasnapur Dist-Parbhani" for conducting the D.Ed. course with immediate effect.

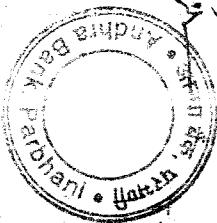


