**WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely **MATA GUJRI MAHILA MAHAVIDYALAYA, JABALPUR, RUN BY GURU GOBIND SINGH EDUCATIONAL SOCIETY, CIVIC CENTER, MARHATAL, JABALPUR - 482002, MADHYA PRADESH (APW03624/225022)** for **M.Ed.** course vide order no. WRC/5-6/92<sup>nd</sup>/2008/38281 dt. 01.08.2008.

AND WHEREAS, the WRC vide order no. WRC/APW03624/225022/140<sup>th</sup>/2010/73194-73200 dt. 04.01.2011 enhanced the intake from 25 to 35, from the academic session 2010-2011.

AND WHEREAS, the Revised Order dt. 21.12.2015, issued for the M.Ed. programme of two years duration with an annual intake of 50 students (One basic unit) from the academic session 2015-2016.

AND WHEREAS, the Institution vide letter dt. 20.06.2016, alongwith resolution of the society had requested to close the M.Ed. course.

AND WHEREAS, WRC vide letter dt. 14.10.2016 had requested to submit the following documents:-

- (1) A copy of No Objection Certificate (NOC) issued by affiliating body (Rani Durgawati University, Jabalpur, M.P.)
- (2) A copy of No Objection Certificate (NOC) issued by State Govt.
- (3) An affidavit by the Secretary of Society informing that the Society has cleared the dues of all the employees.

AND WHEREAS, the reply submitted by institution vide letter dt. 21.10.2016.

AND WHEREAS, the matter was placed before the WRC in its 278<sup>th</sup> meeting held on July 25-26, 2017, the committee decided that:-

"...The institute vide letter dt. 21.10.2016 had admitted that the College is facing problems regarding the M.Ed. course. The institute admits that it requires more time to appoint staff and fulfilling other requirements. Since there is no provision for granting a zero year and more time for rectifying the deficiencies as requested by the management. **Show cause notice be issued to the institution as to why the recognition granted to this course should not be withdrawn. The reply should be received within 15 days.**" Accordingly, Show cause notice was issued on 09.08.2017.

AND WHEREAS, the reply dt. 21.08.2017 submitted by the institution was placed before WRC in its 282<sup>nd</sup> meeting held on October 24-26, 2017 and the Committee decided that "...Show Cause Notice was issued to the institution on 09.08.2017 regarding the M.Ed. course. The institution has requested for continuation of the course for which 08 students have been admitted. To consider the case further, the institution is required to send the list of faculty members duly approved by the competent authority. **Hence, clarification be sought from the institution. Reply should be submitted within one month.**" Accordingly, Clarification letter was issued on 01.11.2017.

AND WHEREAS, the reply dt. 16.11.2017 submitted by the institution was placed before WRC in its 290<sup>th</sup> meeting held on March 21-23, 2018 and the Committee decided that "...Show Cause Notice was issued to the institution on 09.08.2017 regarding staff for the M.Ed. course. Thereafter, clarification letter was issued on 01.11.2017. The institution was asked to submit list of faculty members approved by the Registrar. The institution has not submitted the same. **Hence, Recognition is withdrawn from the end of the next academic session.**"

NOW THEREFORE, the permission granted to **Mata Gujri Mahila Mahavidyalaya, Jabalpur, Civic Center, Marhatal, Jabalpur – 482002, Madhya Pradesh** for conducting M.Ed. programme of 2 year duration with an annual intake of 50 students (One basic unit) vide revised order dated 29.12.2015 **is hereby withdrawn from the academic session 2018-19**, in terms of under section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi – 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
