

**ORDER**

WHEREAS, WRC, NCTE had granted recognition/permission to Maharani Devi Ahilyabai Holkar Education Societies Adhyapak Vidhyalaya House No.468, Near S.T. Stand, Malharpeth-Pandharpur Road, At. Post. Zare, Tal-Atpadi, Dist-Sangli-415301, Maharashtra (APW04258/122944) vide order No. - WRC/5-6/101st/2007/27797 dt- 29.01.2008 for conducting D.El.Ed.course with an annual intake of 50 students.

AND, WHEREAS, the institution vide letter dated 21.06.2016 requested to close the D.El.Edcourse.

AND, WHEREAS, the matter was placed before the WRC in its 258<sup>th</sup>WRC meeting held on August 22-24, 2016, The Committee decided as under:-

"...The Maharani Devi Ahilyabai Holkar Education Societies Adhyapak Vidhyalaya was recognized for D.Ed Course and now they have applied for closure though no Resolution has been submitted, a copy of the No Objection Certificate from Director, MSCERT, Pune of Govt. of Maharashtra dt. 31.05.2016 has been submitted which has given NOC and recommended withdrawal of Recognition of the concerned institution.

**Hence, Closure is permitted. FDRs if any, be returned."**

Now, therefore, the request of the institution for closure of the D.El.Ed.course is hereby accepted and file closed.


