Whereas, recognition was granted to the institution, Arihant College of Education, Arihant Education Foundation, Plot No. 569/1, D.P. Road, Todkar Complex Bibavewadi Kondhwa Road & Parshwavihar, Vadgaon Budruk, Near Suncity, Opp. Shahu Bank, Dist Pune Maharashtra for B.Ed course with an annual intake of 100 students vide order no. F.No.WRC/APW04290/123513/2015/138153- 166 dated 28.05.2015.

And whereas, the Institution vide letter dt. 24.09.2015 submitted an application for **shifting of premises** from Arihant College of Education, Arihant Education Foundation, Plot No. 569/1, D.P. Road, Todkar Complex Bibavewadi Kondhwa Road & Parshwavihar, Vadgaon Budruk, Near Suncity, Opp. Shahu Bank, Dist Pune Maharashtra to **Arihant College of Education, Arihant Education Foundation Sr. No. 276/1/2, 277/1/2, 278/2, Behind Crystal Honda Showroom, New Pune-Mumbai Highway, Bawdhan (BK), Pune - 411021, Maharashtra.**

And whereas, the matter was placed before WRC in its 234th meeting held on November 03-05, 2015. The Committee decided to issue show cause notice to the institution. Accordingly, show cause notice was issued on 17.11.2015 and the institution submitted reply of SCN on 19.11.2015.

And whereas, the matter was placed before WRC in its 242nd meeting held on February 11-13, 2016, The Committee decided that VT be constituted.

And whereas, the inspection of the institution was conducted on 06.03.2016.

And whereas, the matter was placed before the WRC in its 248th meeting held on April 11-12, 2016. The Committee decided as under:-

"...The report of the VT was perused and the CD was viewed. The VT has recommended the case.

Hence, the Shifting is permitted for B.Ed. course."

Now therefore, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted for change of premises from Arihant College of Education, Arihant Education Foundation, Plot No. 569/1, D.P. Road, Todkar Complex Bibavewadi Kondhwa Road & Parshwavihar, Vadgaon Budruk, Near Suncity, Opp. Shahu Bank, Dist Pune Maharashtra to **Arihant College of Education, Arihant Education Foundation Sr. No. 276/1/2, 277/1/2, 278/2, Behind Crystal Honda Showroom, New Pune-Mumbai Highway, Bawdhan (BK), Pune - 411021, Maharashtra,** with immediate effect for conducting B.Ed. course of two years duration with an annual intake of 100 students. **The institution has move towards a composite institution gradually, as per provision of NCTE Regulations, 2014.**
