Restoration of Recognition

Whereas, recognition was granted to SHREE SWAMINARAYAN B.ED COLLEGE , SHREE SHAHJANAND EDUCATION TRUST , F2/20/21 PARTH COMPLEX NEAR T.B. HOSPITEL, VIJAPUR, DISTRICT - MEHSANA, -382875, GUJARAT (code no. APW04330/323430) under section 14 of NCTE Act, 1993 for conducting B.Ed. course of one year duration with an annual intake of 100 students vide order No. WRC/5-6/102nd/2008/30783-30788 dt. 17.03.2008

And whereas, the recognition was withdrawn vide order No. WRC/APW04330/323430/151/2011/80202-80207 dated 25.07.2011, as per decision of 151st meeting of WRC.

And whereas, the institution preferred an appeal before the Council (NCTE) under Section 18 of NCTE Act, 1993. The Appellate Authority vide order no. F. No. 89-400/2011/Appeal/2nd/Meeting - 2012/A49069 dt. 20.03.2012 reversed the withdrawal order dt. 25.07.2011 of WRC with a direction to examine the profile of Principal and taking decision thereafter.

And whereas, the institution filed Special Civil Application no. 6174/2012 before the Hon'ble High Court at Gujarat and the Hon'ble High Court vide order dt. 11.05.2012. directed the Appellate Authority to decide the matter. The Appellate Authority at NCTE, New Delhi heard the matter on 23.05.2012 and confirmed the withdrawal order dated 25.07.2011, of WRC vide appeal order 89-400/2011 Appeal/2nd Meeting -2012 dt. 28.05.2012.

And whereas, again, after this on being aggrieved by the appellate authority order dt. 28.05.2012, the institution filed SCA no. 7855/2012 before the Hon'ble High Court of Gujarat. The Hon'ble High Court vide order dt. 16.06.2012 dismissed the petition filed by the institution.

And whereas, institution filed LPA no. 907/2012 in SCA No. 7855/2012 before the Bench of Hon'ble Chief Justice at Gujarat and the same was dismissed as appeal was devoid of any merit.

And whereas, the institution again preferred an appeal, before the Council.

And whereas, the institution also filed SCA No. 11209 of 2015 and the High Court of Gujarat at Ahmedabad vide order dt. 20.01.2016 disposed the petition with direction to the Appellate Authority to reconsider the matter .

And whereas, the Appellate Authority vide order no 89-10/2016 Appeal/2nd Meeting-2016 dt. 23.03.2016 remanded the case to WRC.

And whereas, the matter was considered by the WRC in its 247th meeting held on 04-06th April, 2016 and the Committee decided to restore recognition of the institution.
