WITHDRAWAL ORDER

WHEREAS, WRC, NCTE had granted permission to the institution namely **SHRI KANWARTARA INSTITUTE FOR TEACHERS TRAINING, SHRINAGAR EXTENSION, PO-GRAM MARDANIA, MANDLESHWAR, TEH.- MAHESHWAR, KHARGONE, MADHYA PRADESH** vide order no. APW05040/ 225065(CO.ED)/WRC/5-6/97/2008/33560 dt. 24.04.2008 for conducting the **M.Ed.** course with an annual intake of 25 students.

AND WHEREAS, the WRC vide order no. WRC/APW05040/225065/140th/2010/73626-73632 dt. 12.01.2011 enhanced the intake from 25 to 35, from the academic session 2010-2011.

AND WHEREAS, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 SHRI KANWARTARA INSTITUTE FOR TEACHERS TRAINING, SHRINAGAR EXTENSION, PO-GRAM MARDANIA, MANDLESHWAR, TEH.- MAHESHWAR, KHARGONE MADHYA PRADESH offering M.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

AND WHEREAS, after the receipt of affidavit dt. 16.01.2015 from the institution, a revised recognition order no. WRC/APW05040/225065/{M.P.}/2015/135315 (Revised Order) dt. 16.05.2015 was issued to the institution for conducting M.Ed. course with an annual intake of 50 students (one basic unit) from the academic session 2015-16.

AND WHEREAS, the WRC vide revised recognition order dt. 16.05.2015 was directed to the institution to submit the following documents in compliance of the NCTE Regulation, 2014:-


1. List of teaching staff duly signed/approved by the affiliating body.
2. Dully notarized CLU/NEC/BP and Building Completion Certificate.
3. Proof of maintaining the Endowment fund and Reserve fund as per NCTE regulations, 2014.

AND WHEREAS, the matter regarding compliance by the institution of the condition mentioned in revised recognition order was placed before WRC in its 255th Meeting held on June 22-24, 2016 and the Committee decided that "...Show Cause Notice be issued to all such institutions which have not submitted compliance."

AND, WHEREAS, a Show cause notice was issued to the institution on 13.01.2017 for not submitting compliance of Regulation 2014 required faculty staff list for 50 students and infrastructure.

AND WHEREAS, the reply of Show cause notice dt. 13.01.2017 not submitted by the institution. The matter was placed before the WRC in its 290th meeting held on March 21-23, 2018 and the Committee decided that "...Show Cause Notice was issued to the institution on 13.01.2017. The institution has not replied so far. Hence, Recognition is withdrawn from the end of the next academic session."

NOW THEREFORE, the permission granted to **SHRI KANWARTARA INSTITUTE FOR TEACHERS TRAINING, SHRINAGAR EXTENSION, PO-GRAM MARDANIA, MANDLESHWAR, TEH.- MAHESHWAR, KHARGONE, MADHYA PRADESH** for conducting M.Ed. programme of 2 year duration with an annual intake of 50 students (One basic unit) vide revised order dated 16.05.2015 is **hereby withdrawn from the academic session 2018-19**, in terms of section 17(1) of the NCTE Act, 1993.
