WITHDRAWAL ORDER

WHEREAS, permission was granted to **YUVA VYAVASAIK SHIKSHAN SANSTHAN, NEAR RAILWAY OVER BRIDGE, GUNA - 473001, MADHYA PRADESH** under section 15 of NCTE Act, 1993 for conducting M.Ed. course vide order dated 31.12.2007 for an annual intake of 25 seats and enhancement of intake was permitted vide order dated 11.01.2011 from 25 to 35 seats.

AND WHEREAS, Letter dated 05.09.2013 was issued to the institution informing that the said institution does not fulfill the provisions as laid down in the Clause 8(5) of NCTE Regulations, 2009, and therefore, the name of the said institution no more figures in the list of recognized institutions of M.Ed. course.

AND WHEREAS, the institution had filed W.P. No. 3648/2014 before the Hon'ble High Court of Madhya Pradesh, Principal seat at Jabalpur, bench at Gwalior. The Hon'ble High Court has passed an order dated 30.06.2014.

AND WHEREAS, the aforesaid Court order was placed before the WRC in its 209th meeting held on August 20, 2014 and the Committee decided that "...Vide NCTE Letter No. 49-3/2011/NCTE/N&S/ dated 13.07.2012, attention was invited towards the requirement of Accreditation from NAAC to those teacher training institutions who have been granted additional intake in B.Ed., B.P.Ed., & M.Ed. & M.P.Ed. courses as stipulated in sub clause (5) of clause 8 of National Council for Teacher Education (Recognition, Norms & Procedure) Regulations, 2009. This letter was uploaded on the web-site of NCTE, Bhopal on www.nctewrc.co.in. As a follow up, the institutions were also informed in writing about the Regulatory Provision for NAAC Accreditation. The institution YUVA VYAVASAIK SHIKSHAN SANSTHAN, GUNA approached the Hon'ble High Court of Madhya Pradesh, Principal Seat at Jabalpur, Bench at Gwalior. Vide their order dated 30.06.2014, the Hon'ble High Court have quashed, 'the impugned action', while giving liberty to the NCTE to proceed afresh in accordance with the law. **Hence, Show Cause Notice be issued to the institution on the basis of NCTE letter dated 13.07.2012.**"

AND WHEREAS, Show cause notice dated 26.08.2014 was issued under section 17(1) of the NCTE Act, 1993, an opportunity was given to the institution as to why recognition/permission granted to the institution should not be withdrawn for violation of norms and standards of NCTE on the following grounds:

- As per Clause 8(5) of NCTE Regulation, 2009, "An institution that has been granted additional intake in Bachelor of Education and Bachelor of Physical Education teacher training courses after promulgation of the Regulations, 2005 i.e. the 13th day of January 2006 shall have to get itself accredited by National Assessment and Accreditation Council (NAAC), with a Letter Grade B under the new grading system developed by NAAC, on or before the 1st day of April, 2011 failing which the additional intake granted shall stand withdrawn with effect from the academic session 2011-2012. Similarly, all institutions having a Master of Education and Master of Physical Education courses shall have to get NAAC Accreditation with at least a Letter Grade B on or before the 1st day of April, 2012, failing which Master of Education or Master of Physical Education Recognition granted to the institution shall stand withdrawn with effect from the academic session 2012-2013."

AND WHEREAS, the institution vide letter dated 25.09.2014 received in WRC on 01.10.2014 institution in its reply stated that "... we have applied for NAAC accreditation inspection on 27.11.2011 i.e., prior to 1st April 2012 we do not come under the preview withdrawal of recognition. Therefore, it is requested kindly reconsider our case and issue us the letter of continuation of our M.Ed. course." Thereafter, institution again vide letter dated 25.09.2014 received in WRO on 07.10.2014 has requested that "...कि युवा व्यावसायिक शिक्षण महाविद्यालय गुना मध्यप्रदेश एम.पी.एड., एम.एड. सत्र 2014-15 पाठ्यक्रम में प्रवेश लेना बंद कर दिया है तथा महोदय से निवेदन है इन पाठ्यक्रमों की मान्यता उपरोक्त दिये गये सत्रों से समाप्त करने की कृपा करें।"

AND WHEREAS, the matter was placed before the WRC in its 212th meeting held on November 28-29, 2014 and the Committee decided that "...Yuva Vyavsaik Shikshan Sansthan, Guna has applied for closing the M.P.Ed. and M.Ed. course from the session 2014-2015 on the grounds of not getting any students. But resolution of the Society to this effect has not been submitted.

Hence, the Society be asked to submit the original resolution for closing the course so that necessary action can be taken." Accordingly, Compliance letter was issued to the institution on 22.12.2014.

AND WHEREAS, the reply of Compliance letter not received, the matter was placed before the WRC in its 288th meeting held on February 15-16, 2018. The Committee decided that "...The institution vide letter dated 25.09.2014 has requested for closure of M.Ed. course. Compliance letter for submission of resolution of society was issued on 22.12.2014. Reply has not been received till date. **Hence, Recognition is withdrawn from the academic session 2018-2019."**

NOW THEREFORE, the permission granted to **YUVA VYAVASAIK SHIKSHAN SANSTHAN, NEAR RAILWAY OVER BRIDGE, GUNA - 473001, MADHYA PRADESH** for conducting M.Ed. course vide permission order dated 31.12.2007 & 11.01.2011 is hereby withdrawn in terms of under section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order for filling of appeal may be seen on NCTE website www.ncte-india.org.
