Withdrawal Order U/S-17

Whereas, recognition was granted to the institution, namely, NEEL KANTH SHIKSHA MAHAVIDHYALAYA, VIKRAMPURA WARD NO. 11 NEAR B.T.I. NEEL KANTH BIHAR COLONY, MAHAVEER NAGAR, BHIND-477001, MADHYA PRADESH (APW06716/223715) for B.Ed. Course vide order dated 19-02-2009.

AND WHEREAS, one Shri Pawan Dubey filed a PIL in the Hon'ble High Court of Madhya Pradesh at Jabalpur. The Hon'ble High Court directed to inspect all B.Ed. institutions in the State of Madhya Pradesh. Since the institutions are existing institutions, the inspection was conducted by NCTE Hqrs. u/s 13 of the NCTE Act.

AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 05-02-2015.

AND WHEREAS, Revised Recognition order was issued to the institution on 30.05.2015.

AND WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 03.09.2014.

AND WHEREAS, the Deficiency Letter was issued by the NCTE Hqrs. to the institution on 06.05.2015 and the reply of Deficiency Letter was received and forwarded to NCTE Hqrs. on 26-06-2015.

AND WHEREAS, the VTR alongwith file of the institution were received from NCTE Hqrs. in WRO on 03.02.2016.

AND WHEREAS, the matter was placed before the WRC in its 252nd Meeting held on May 09-10, 2016 and the Committee decided that "...Deficiency letter was issued to the institution on 06/05/2015 and reply was received on 26/06/2015. The points are as under:-

i) The institution was asked to provide status of building construction and furnish the Building Completion Certificate.

The institution has submitted an undated letter from Municipal Council of Bhind, that the construction is complete. The institution has not submitted the Building Completion Certificate in the prescribed format.

ii) The institution has not maintained Endowment and Reserved Funds.

The institution has now submitted FDRs in original.

iii) The institution has not replied to the point regarding shortage of classrooms and inadequately equipped Labs.

iv) The institution was asked to furnish University approved list of teaching staff, and appointment of a teacher in Art Education.

The institution has not submitted composite list of faculty members in the prescribed format.

v) The institution has also not replied to the observation regarding updating of website.

Hence, Show Cause Notice be issued under section 17, on the above grounds.

AND WHEREAS, Show Cause Notice was issued to the institution on 18.05.2016. The institution submitted reply dated 16-06-2016 of the show cause notice.

AND WHEREAS, the matter was placed in 256th meeting of WRC held on July 19-21, 2016 and the

Committee decided that "...In response to the Show Cause Notice dt. 18/05/2016, the institution has filed a Building Completion Certificate dt. 11/04/2007. This course was recognized in 2009 vide recognition order dt. 19/02/2009. When the Central Team inspected the premises on 03/09/2014, they have observed that the building is still incomplete. It has been claimed that two more rooms have been added, but no authentic proof has been provided. A photocopy of an un-dated letter purportedly from Nagar Palika, Bhind has been provided, which is not at all trustworthy. Neither the letterhead nor the content, are in the usual wording of Certificates given by the municipal bodies. Hence, this point of the Show Cause Notice is not satisfied.

One point related to the submission of composite list of faculty members in the prescribed format. The institution has supplied a photocopy of a staff list which is not even approved by the affiliating body. Further, since this institution is recognized for two units of B.Ed. vide revised order dt. 30/05/2015, the institution should have submitted a staff list of 16 faculty members as per Appendix-4 of the NCTE Regulations, 2014. This has also not been done.


Even though full opportunity was given to the institution to rectify the shortcomings vide a deficiency letter dt. 06/05/2015 and Show Cause Notice dt. 18/05/2016, no effort was made in this context.

Hence, Recognition is withdrawn under Section 17 of the NCTE Act, from the end of the academic session, next following the date of Order of withdrawal"

Now, therefore, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted to the institution for conducting B.Ed. course, is hereby withdrawn from the end of the academic session next following the date of order of Withdrawal.

Further, if the institution is not satisfied by the order, it may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 **online** against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
