WHEREAS, recognition was granted to the institution namely, R.D. MEMORIAL COLLEGE OF PHYSICAL EDUCATION, KHASRA NO.118, 119, 120/1, 102/2, 134/1/1, 134/2/4, VILLAGE: BARKHEDI KALAN, BHADBHADA ROAD, BHOPAL, MADHYA PRADESH under section 15 of NCTE Act, 1993 for conducting M.P.Ed. course with an annual intake of 30 students vide order dated 18.08.2008.

AND WHEREAS, Barkatullah University conducted inspections in B.P.Ed./M.P.Ed. colleges on the basis of complaints received against the institutions. Accordingly, the matter was placed in the 271st WRC Meeting held on March 23-25, 2017 and it was decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued on 21.04.2017. Reply not submitted by the institution. The matter was placed in the 277th WRC meeting held on June 29-30, 2017 and it was decided that, "...Show Cause Notice was issued to the institution on 21/04/2017. The institution has not replied to the Show Cause Notice till date. Hence, Recognition is withdrawn...". Accordingly, withdrawal order for B.P.Ed. course issued on 04.07.2017.

AND WHEREAS, the WRC in its 286th meeting held on January 16-17, 2018 decided as follows "...The recognition for B.P.Ed. course (APW02660/224104) has been withdrawn vide order dated 04.07.2017. As such, the M.P.Ed. course becomes stand alone. Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month." Accordingly, Show Cause Notice was issued on 24.01.2018.

AND WHEREAS, reply not received from the institution. The matter was placed before WRC in its 290th meeting held on March 21-23, 2018 and the Committee decided that "...Show Cause Notice was issued to the institution on 24.01.2018 regarding closure of the M.P.Ed. course. The institution has not replied till date. Hence, Recognition for M.P.Ed. course is withdrawn from the end of the next academic session."

NOW THEREFORE, the recognition granted to R.D. MEMORIAL COLLEGE OF PHYSICAL EDUCATION, KHASRA NO.118, 119, 120/1, 102/2, 134/1/1, 134/2/4, VILLAGE: BARKHEDI KALAN, BHADBHADA ROAD, BHOPAL, MADHYA PRADESH for conducting M.P.Ed. course vide order dated 18.08.2008 is hereby withdrawn under section 17(1) of the NCTE Act, 1993 from the end of the next academic session.

Further, if the institution is not satisfied by the order, it can prefer an appeal online to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
