WITHDRAWAL ORDER

Whereas, the WRC had granted the recognition to Margdarshan Sansthan Shiksha Mahavidyalaya, (Run by Margdarshan Sansthan), Shri Sarveshwari Nagar, Baikunthpur, Koria - 497335, Chhattisgarh for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/121st/2009/57443 dt. 11.07.2009.

And whereas, the recognition of the institution was withdrawn in its 164th meeting of WRC held on June, 6-8, 2012 for conducting B.Ed. course on following grounds:-

"The institution has submitted reply only on the point of Staff. While the institution has made the selection, the appointment is still not approved by the affiliating University. The institution has not replied to the other point regarding CLU."

And whereas, the Withdrawal order was issued to the institution vide order No. WRC/APW08061/723167/164th/2012/93801 dt. 06.08.2012.

And whereas, institution was file an appeal before the Appeal Committee, NCTE, New Delhi on 04.10.2012 and Appeal Committee had decided the appeal of institution on 28.02.2013 with the direction of " the Council hereby remands back the case of Margdarshan Sansthan Shikshan Shiksha Mahavidyalaya, Koriya, Chhattisgarh to the WRC, NCTE for necessary action as indicated above".

And whereas, the Restoration of Recognition order was issued to Margdarshan Sansthan Shiksha Mahavidyalaya Bainskathpur, Shri Sarveshwari Nagar, Baikunthpur, Koria - 497335, Chhattisgarh for conducting B.Ed. course vide order No. WRC/APW08061/723167/188th/2013/107311 dt. 29.08.2013.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Margdarshan Sansthan Shiksha Mahavidyalaya, (Run by Margdarshan Sansthan), Shri Sarveshwari Nagar, Baikunthpur, Koria - 497335, Chhattisgarh offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.


And whereas, after the receipt of affidavit dt. 02.02.2015 from the institution, a revised recognition order no. WRC/APW08061/723167/B.Ed./2015/140106 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students each) from session 2015-16.

And whereas, the letter No. 2062/Acad./Inspection/2017 dt. 04.09.2017 received from the Registrar, Sarguja University, Ambikapur, Chhattisgarh was placed before the WRC in its 281st Meeting held on 19th - 20th September, 2017 and the Committee decided as follows :-

"The Registrar, Bilaspur University, Bilaspur vide letter dt. 06.09.2017 has brought to the notice of the WRC that following institutions don't have Regular qualified Principal/Staff. The University has temporarily suspended the affiliation of these institutions and requested WRC to take further action in the matter as per NCTE Regulations, 2014.

The WRC decided to issue Show Cause Notice to the institutions."

And whereas, Show Cause Notice was issued to the institution on 23.10.2017 and the reply dt. 06.11.2017 of institution was placed before the WRC in its 284th Meeting held on November 28th - 29th, 2017 and the Committee decided as follows :-

"The case file was seen. Show Cause Notice was issued to the institution on 23.10.2017 based on the letter written by the Registrar, Sarguja University, Ambikapur against Margdarshan Sansthan Shiksha Mahavidyalaya. Reply given by the institution is vague and not supported by facts.

Hence, Recognition is withdrawn from the academic session 2018-2019. FDRs, if any be returned"

Now, therefore, the recognition of Margdarshan Sansthan Shiksha Mahavidyalaya, (Run by Margdarshan Sansthan), Shri Sarveshwari Nagar, Baikunthpur, Korla - 497335, Chhattisgarh for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is **hereby withdrawn from the academic session 2018-2019** in terms of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
